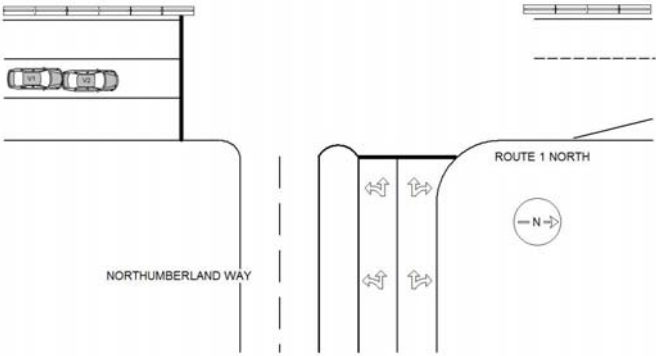
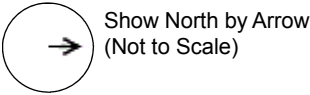

VEHICLE #1 STRUCK VEHICLE #2 WHILE IN TRAFFIC ON RT. 1 NORTH AT NORTHUMBERLAND WAY.

DRIVER #1 STATED THAT SHE WAS TOO CLOSE TO VEHICLE #2 AND STRUCK IT.

DRIVER #2 STATED THAT SHE WAS STRUCK FROM BEHIND.

NEITHER PARTY APPEARED INJURED AND BOTH REFUSED MEDICAL ASSISTANCE.
