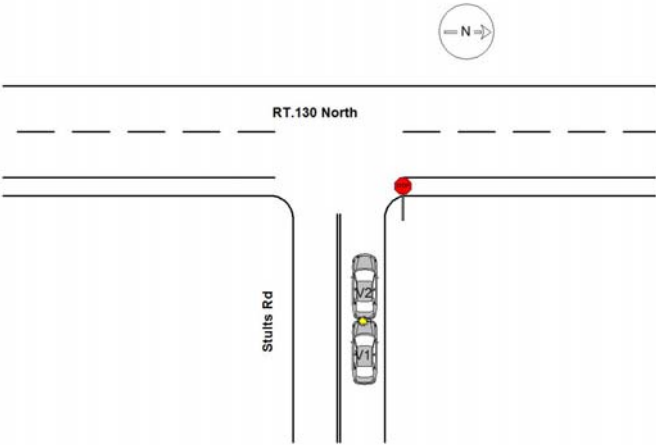

DRIVER 1 STATED IN EFFECT, WHILE TRAVELING STULTS RD SHE REAR ENDED VEHICLE 2 TO NEAR THE STOP SIGN AT STULTS RD AND RT.130 NORTH.

DRIVER 2 STATED IN EFFECT, WHILE STULTS RD SHE WAS REAR ENDED BY VEHICLE 1 NEAR THE STOP SIGN AT STULTS RD AND RT.130 NORTH.

MY INVESTIGATION SHOWS DRIVER 1 AT FAULT FOR THIS CRASH. DRIVER 1 WAS ISSUED A SUMMONS FOR CARELESS DRIVING.
