

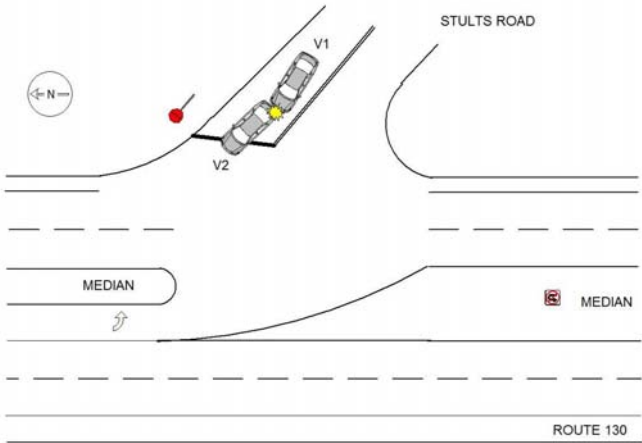

145 Crash Description

D1 STATED IN SUMMARY HE WAS DRIVING WEST ON STULTS ROAD AND WAS STOPPED BEHIND V2 AT THE STOP SIGN FOR THE INTERSECTION OF ROUTE 130. D1 STATED HE THOUGHT V2 HAD PROCEEDED NORTH ON ROUTE 130 AND BEGAN TO MOVE FORWARD AT WHICH POINT HIS VEHICLE IMPACTED V2 IN THE REAR.

D2 STATED IN SUMMARY HE WAS DRIVING WEST ON STULTS ROAD AND WAS STOPPED AT THE STOP SIGN AT THE INTERSECTION OF ROUTE 130 WHEN HIS VEHICLE WAS IMPACTED IN THE REAR BY V1.
