

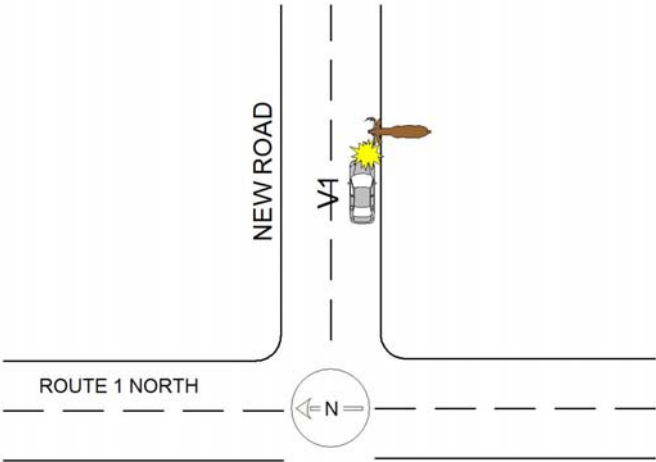

145 Crash Description

DRIVER #1 STATED, IN EFFECT, HE WAS TRAVELING EAST ON NEW ROAD WHEN HE STRUCK A DEER. DRIVER #1 FURTHER STATED, HE WAS UNABLE TO AVOID THE IMPACT AS THE DEER SUDDENLY MERGED ONTO HIS LANE OF TRAVEL STRIKING HIS VEHICLE. VEHICLE #1 SUSTAINED FRONT END DAMAGE.
