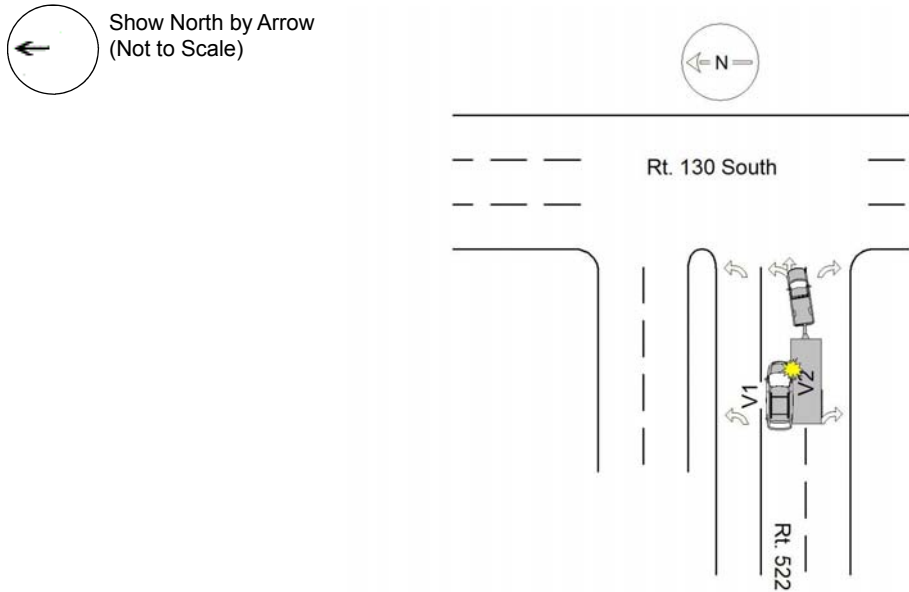

D1 STATED, IN EFFECT, THAT WHILE APPROACHING THE RED LIGHT AT THE INTERSECTION OF RT. 522 AND RT. 130 SOUTH SHE DID NOT SEE THAT THE TRAILER FROM V2 WAS PARTIALLY IN THE LANE WITH ITS DIRECTIONAL SIGNAL ON. SHE STATED THAT V2 WAS STOPPED AT THE LIGHT AND SHE MISJUDGED THE DISTANCE BETWEEN HER VEHICLE AND THE TRAILER. D2 STATED, IN EFFECT, THAT WHILE STOPPED AT THE LIGHT HIS TRAILER WAS STRUCK BY V1 WHO DROVE UP ALONG THE SIDE OF HIM. BOTH VEHICLES HAD MINOR DAMAGE AND DID NOT REQUIRE TOWS. NO INJURIES WERE REPORTED.
