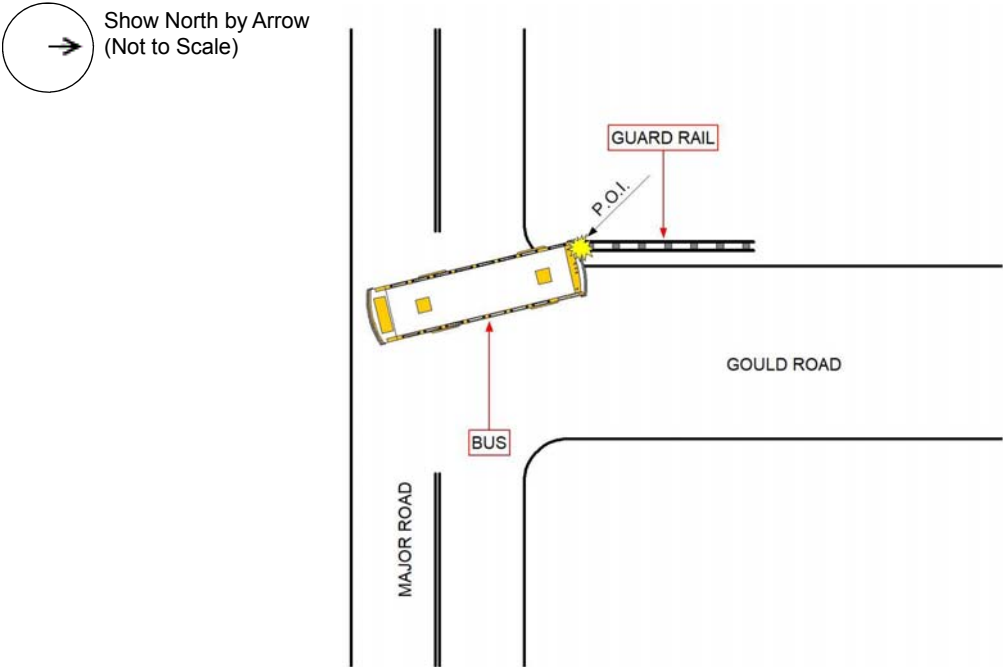

D1 STATED HE WAS REVERSING DOWN GOULD ROAD IN ORDER TO EXECUTE A K-TURN. THAT IS WHEN THE REAR OF THE SCHOOL BUS STRUCK THE GUARD RAIL. GEORGES GARAGE RESPONDED TO LIFT THE SCHOOL BUS FROM THE GUARD RAIL. THE SCHOOL BUS WAS STILL OPERABLE. THE OCCUPANTS WERE PROVIDED TRANSPORT BY A DIFFERENT SCHOOL BUS. NO INJURIES WERE REPORTED OR OBSERVED.
