

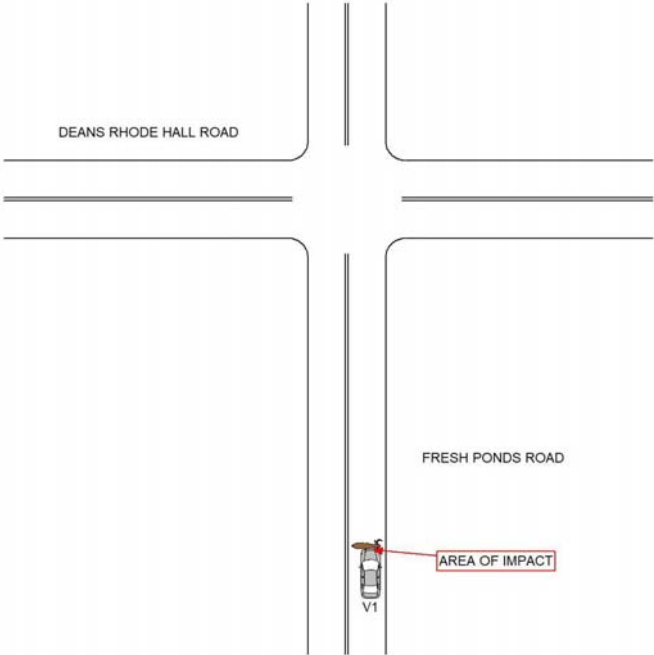

D1 STATED HE WAS TRAVELING NORTHBOUND ON FRESH PONDS ROAD APPROACHING DEANS RHODE HALL ROAD. HE STATED AS HE WAS TRAVELING, A DEER ENTERED THE ROADWAY. HE STATED HE ATTEMPTED TO AVOID THE DEER BUT WAS UNABLE TO DO SO. THE DEER WAS DECEASED AND OFF THE ROADWAY UPON MY ARRIVAL.

V1 SUSTAINED DAMAGE TO THE FRONT BUMPER AND GRILL. D1 DID NOT REPORT ANY INJURIES. DPW WAS NOTIFIED FOR REMOVAL OF THE DEER.
