

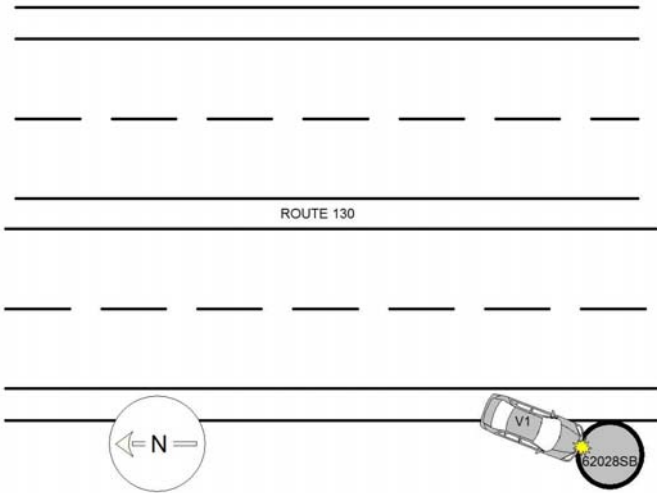

145 Crash Description

D1 STATED IN EFFECT THAT WHILE TRAVELING SOUTH ON RT 130, SHE WAS SPEAKING WITH HER SISTER OVER THE PHONE USING THE BLUE TOOTH FEATURE THROUGH HER VEHICLE SPEAKER SYSTEM. DURING THE CONVERSATION ABOUT BLOOD, D1 STATED SHE PASSED OUT BEHIND THE WHEEL AND STRUCK A POLE.

AS A RESULT OF STRIKING THE POLE, D1 OBTAIN A SMALL LACERATION ABOVE HER EYE. SHE WAS TRANSPORTED TO PRINCETON MEDICAL CENTER FOR EVALUATION. THE VEHICLE AIRBAGS DID NOT DEPLOY.
