

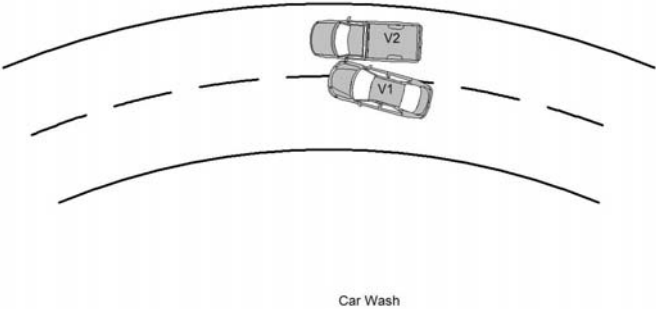

145 Crash Description

VEHICLE #1 WAS WAITING IN LINE AT THE CAR WASH, WHEN DRIVER #1 DECIDED TO CHANGE LANES. VEHICLE #1 STRUCK VEHICLE #2 DURING THE COURSE OF THIS LANE CHANGE.

DRIVER #1 HAD DECIDED NOT TO WAIT IN LINE FOR THE WASH PRIOR TO CHANGING LANES.

DRIVER #2 STATED THAT VEHICLE #1 RAPIDLY CHANGED LANES AND STRUCK HIM.

NEITHER PARTY APPEARED INJURED AND BOTH REFUSED MEDICAL ASSISTANCE.
