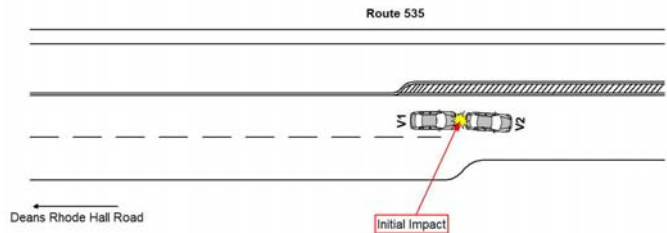
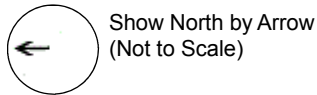

145 Crash Description

DRIVER 1 STATED HE WAS TRAVELING SOUTH ON ROUTE 535, SOUTH OF DEANS RHODE HALL ROAD, WHEN HE OBSERVED VEHICLE 2 COME TO AN ABRUPT STOP AHEAD OF HIM. IT WAS AT THIS TIME THAT DRIVER 1 ATTEMPTED TO STOP HIS VEHICLE, HOWEVER HE WAS UNABLE TO DO SO PRIOR TO THE FRONT OF HIS VEHICLE MAKING CONTACT WITH THE REAR OF VEHICLE 2.

DRIVER 2 STATED SHE WAS TRAVELING SOUTH ON ROUTE 535, SOUTH OF DEANS RHODE HALL ROAD, WHEN SHE SWERVED AND STOPPED HER VEHICLE DUE TO TRAFFIC CONDITIONS AHEAD OF HER. IT WAS AT THIS TIME THAT SHE FELT THE IMPACT OF VEHICLE 1 MAKING CONTACT WITH THE REAR OF HER VEHICLE.

INVESTIGATION DETERMINED DRIVER 1 TO BE AT FAULT FOR FAILING TO MAINTAIN A SAFE FOLLOWING DISTANCE.

DRIVER 2 HAD A COMPLAINT OF HEAD/NECK PAIN AS A RESULT OF THE CRASH, HOWEVER SHE REFUSED ANY MEDICAL ASSISTANCE WHILE OFFICERS WERE ON SCENE.

IT SHOULD BE NOTED THAT THE DAMAGE PRODUCED FROM THIS CRASH DID NOT APPEAR TO BE INDICATIVE OF THAT WHICH WOULD CAUSE INJURIES.
