

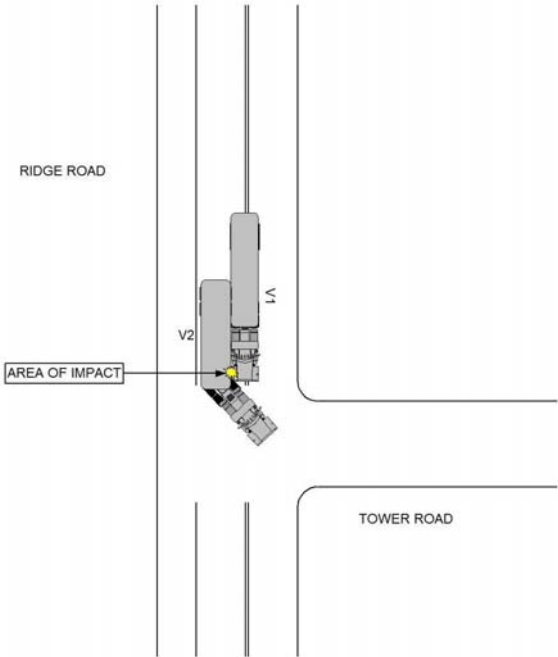

D1 STATED IN EFFECT THAT V1 WAS TRAVELING WEST ON RIDGE ROAD. D1 FURTHER STATED THAT V2 ATTEMPTED TO MAKE LEFT TURN FROM THE SHOULDER AND STRUCK V1.

D2 STATED IN EFFECT THAT V2 WAS TRAVELING WEST ON RIDGE ROAD. D2 FURTHER STATED THAT V2 WAS MAKING A LEFT TURN ONTO TOWER ROAD AND WAS SIDESWIPED BY V1. D2 STATED THAT V1 WAS ATTEMPTING TO PASS V2 OVER THE DOUBLE YELLOW LANE MARKINGS.
