

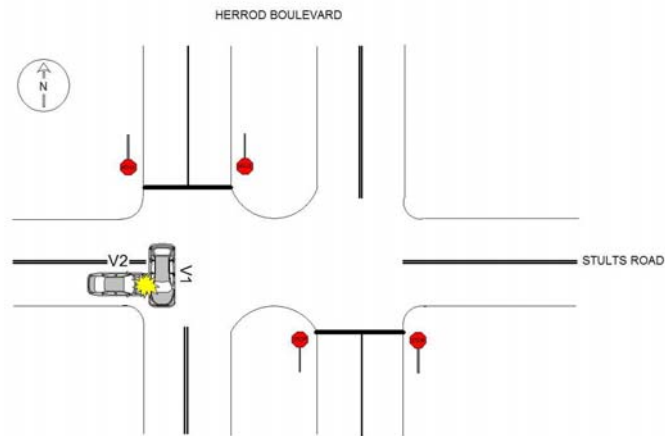

145 Crash Description

D2 STATED, IN EFFECT, THAT SHE WAS DRIVING EASTBOUND ON STULTS ROAD WHEN V1 ENTERED THE INTERSECTION FROM HERROD BOULEVARD SOUTHBOUND AND COLLIDED WITH HER VEHICLE. D2 SAID THE DRIVER OF V1 THEN EXITED HER VEHICLE, TOLD D2 THAT SHE WAS A "NURSE," CHECKED ON HER WELL-BEING BRIEFLY, RE-ENTERED V1, AND THEN DROVE AWAY FROM THE SCENE. D2 DESCRIBED THE DRIVER OF V1 AS A BLACK FEMALE WITH "BRAIDS" AND DESCRIBED V1 AS A "TAN" VEHICLE WITH NO OTHER DESCRIPTORS.

D2 COMPLAINED OF PAIN IN HER RIGHT HAND AND SUSTAINED A MINOR LACERATION TO HER NOSE. SHE WAS EVALUATED BY SOUTH BRUNSWICK EMS (#A58) BUT REFUSED TRANSPORT TO THE HOSPITAL.

SEVERAL BYSTANDERS WHO OBSERVED THE AFTERMATH OF THE CRASH REPORTED THAT V1 WAS A BROWN BMW, AND IT FLED WESTBOUND ON STULTS ROAD. A CHECK OF THE AREA YIELDED NEGATIVE RESULTS. NO ONE WAS ABLE TO PROVIDE IDENTIFIERS.
