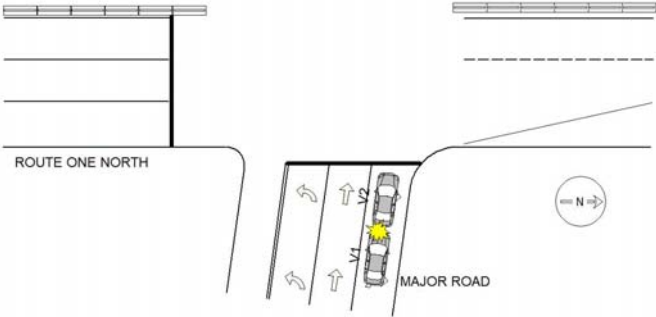
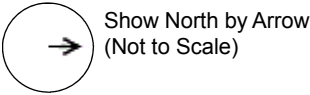

145 Crash Description

DRIVER #1 STATED, IN EFFECT, HE WAS TRAVELING WEST ON MAJOR ROAD WHEN HE STRUCK VEHICLE #2. DRIVER #1 FURTHER STATED, HE WAS UNABLE TO STOP ON TIME IN TRAFFIC, AS A RESULT REAR ENDING VEHICLE #2. DRIVER #2 STATED, IN EFFECT, SHE WAS COMING TO A SLOW STOP IN TRAFFIC WHEN HER VEHICLE WAS REAR ENDED. VEHICLE #1 SUSTAINED FRONT END DAMAGE AND REQUIRED A TOW. VEHICLE #2 SUSTAINED MINOR REAR END DAMAGE. NO INJURIES WERE REPORTED OR OBSERVED AT THE SCENE.
