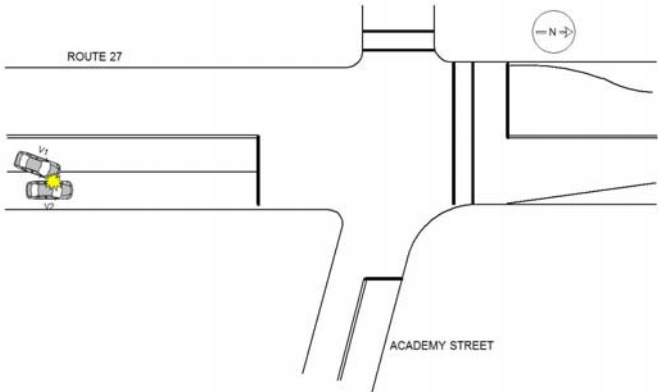

145 Crash Description

DRIVER #1 STATED, IN EFFECT, SHE WAS ATTEMPTING TO MERGE ONTO THE LEFT LANE WHEN SHE STRUCK VEHICLE #2. DRIVER #1 FURTHER STATED, SHE DID NOT SEE VEHICLE #2 TRAVELING NORTH ON THE RIGHT LANE AS A RESULT CAUSING THE IMPACT. DRIVER #2 STATED, IN EFFECT, SHE WAS TRAVELING NORTH ON ROUTE 27 WHEN VEHICLE #1 SUDDENLY MERGED ONTO HER LANE OF TRAVEL STRIKING HER VEHICLE. VEHICLE #1 SUSTAINED MINOR PASSENGER SIDE DAMAGE. VEHICLE #2 SUSTAINED DAMAGE ON THE DRIVERS SIDE. NO INJURIES NO TOWS.
