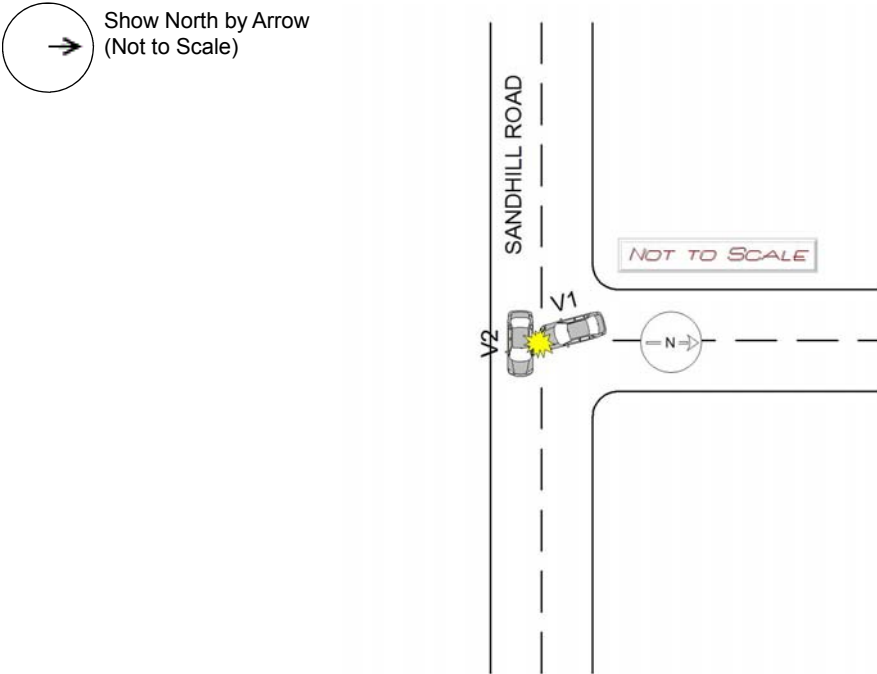

145 Crash Description

DRIVER #1 STATED, IN EFFECT, HE WAS MAKING A LEFT TURN ONTO SANDHILL ROAD WHEN HE STRUCK VEHICLE #2. DRIVER #1 FURTHER STATED, HE DID NOT SEE VEHICLE #2 TRAVELING EASTBOUND AS A RESULT CAUSING THE IMPACT. DRIVER #2 STATED, IN EFFECT, HE WAS TRAVELING EAST ON SANDHILL ROAD WHEN VEHICLE #1 SUDDENLY MERGED ONTO HIS LANE OF TRAVEL STRIKING HIS VEHICLE. VEHICLE #1 SUSTAINED FRONT END DAMAGE. VEHICLE #2 SUSTAINED DAMAGE ON THE REAR DRIVERS SIDE. NO INJURIES NO TOWS.
