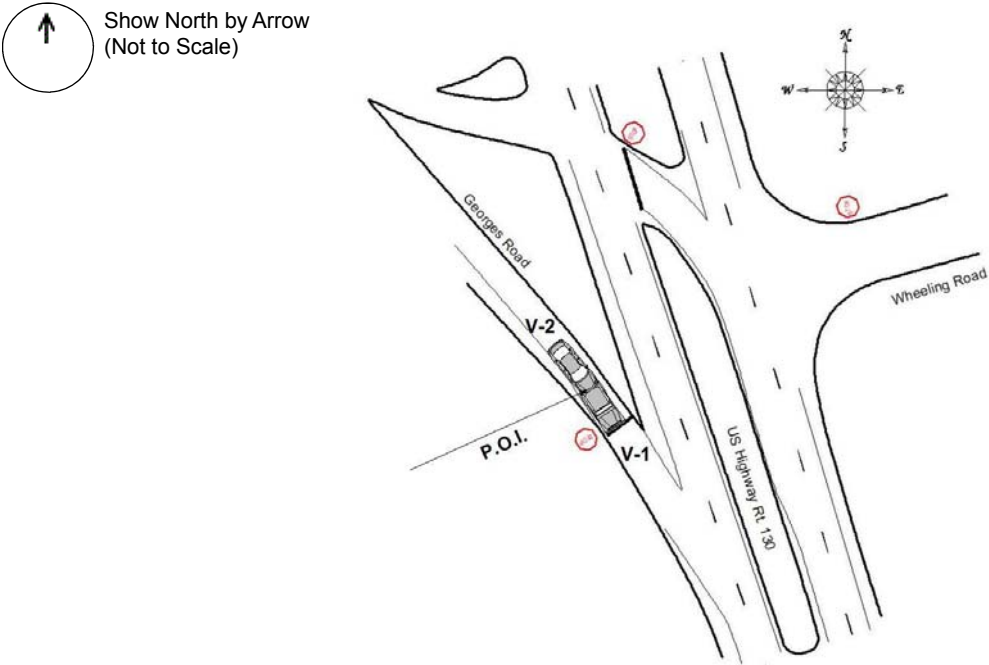

DRIVER OF VEHICLE # 1 STATES HE WAS TRAVELING SOUTH ON GEORGES ROAD AND STOPPED AT THE STOP SIGN AT GEORGES ROAD AND RT. 130 SOUTH. DRIVER OF VEHICLE # 1 WAS WAITING FOR TRAFFIC TO CLEAR TO MERGE ONTO RT. 130 SOUTH, VEHICLE # 1 WAS STRUCK FROM BEHIND BY VEHICLE # 2.

DRIVER OF VEHICLE # 2 STATES HE WAS TRAVELING SOUTH ON GEORGES ROAD AND STOPPED BEHIND VEHICLE # 1. VEHICLE # 1 PROCEEDED FORWARD AND STOPPED. THE DRIVER OF VEHICLE # 2 PROCEEDED BEHIND VEHICLE # 1.
