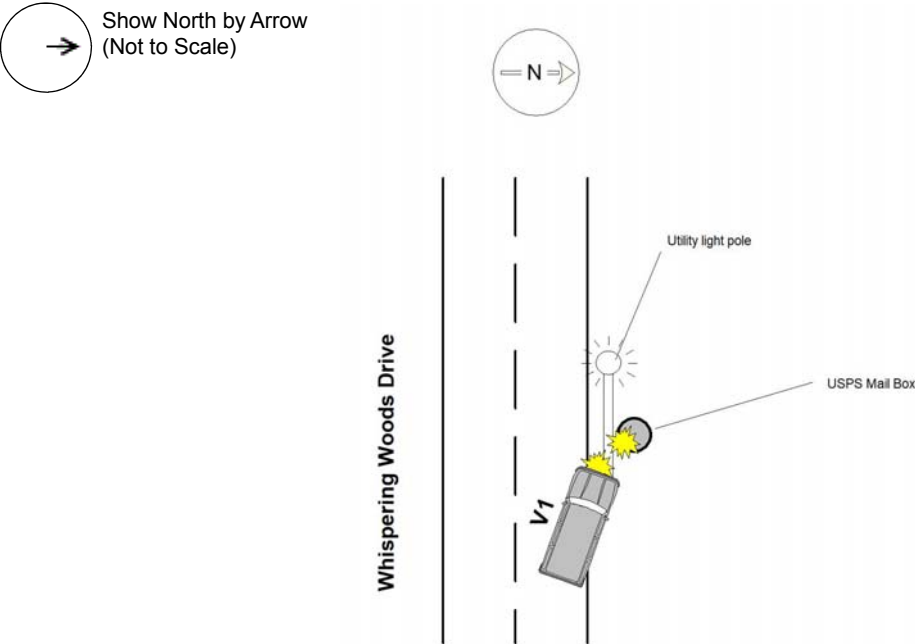

D1 STATED IN EFFECT, THAT HE WAS TRAVELLING WESTBOUND ON WHISPERING WOODS DRIVE WHEN SUDDENLY A DEER RAN OUT IN FRONT OF HIS VEHICLE. IN AN EFFORT TO AVOID THE DEER HE SWERVED TO THE RIGHT, RUNNING OFF THE ROAD AND IMPACTING A UTILITY LIGHT POLE AS WELL AS A USPS MAIL COLLECTION BOX. D1 ADVISED HE DID NOT STRIKE THE DEER.
