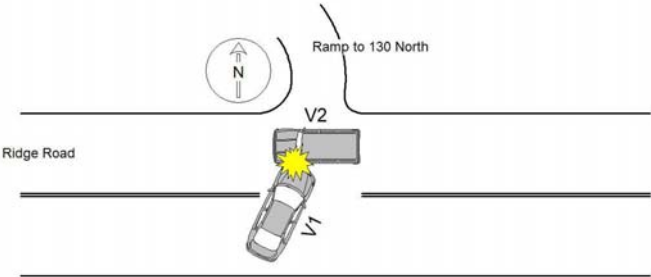
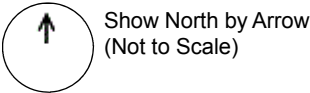

145 Crash Description

D1 STATED, IN EFFECT, THAT SHE WAS MAKING A LEFT FROM RIDGE ROAD EASTBOUND ONTO THE RAMP FOR ROUTE 130 NORTHBOUND WHEN V2, WHICH D1 SAID WAS "GOING VERY FAST," COLLIDED WITH HER VEHICLE. D2 STATED, IN EFFECT, THAT HE WAS GOING WESTBOUND ON RIDGE ROAD WHEN V1 MADE A LEFT TURN INTO HIS PATH AND STRUCK HIS VEHICLE. D1 AT FAULT. D2 COMPLAINED OF SHOULDER PAIN AT THE SCENE BUT REFUSED MEDICAL ATTENTION. *D2 PROVIDED AN INSURANCE CARD FOR PALISADES INSURANCE COMPANY (908-790-6900; NAIC NUMBER LISTED ABOVE).
