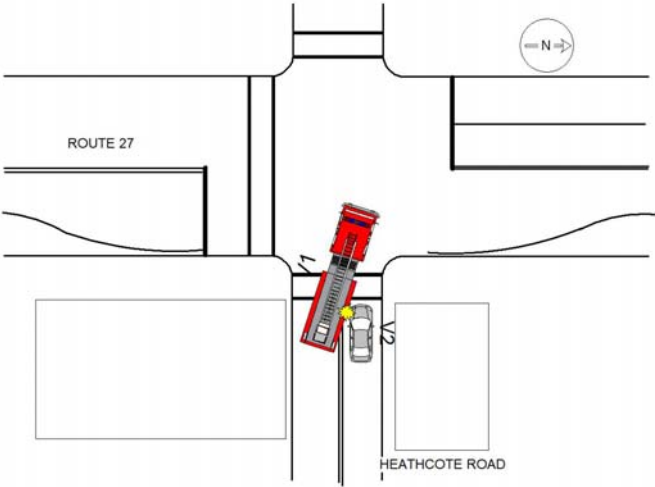
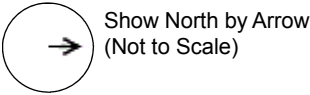

145 Crash Description

DRIVER #1 STATED, IN EFFECT, HE WAS OPERATING THE FIRE TRUCK RESPONDING TO A CALL WITH LIGHTS AND SIRENS ON. DRIVER #1 FURTHER STATED, THE THEN CROSSED OVER THE DOUBLE YELLOW LINES AND DROVE AROUND A VEHICLE STOPPED AT THE RED LIGHT. DRIVER #1 STATED HE THEN EXECUTED A RIGHT TURN ONTO ROUTE 27 NORTH AND WAS NOT AWARE THAT HIS VEHICLE MADE CONTACT WITH VEHICLE #2. DRIVER #2 STATED, IN EFFECT, SHE WAS STOPPED AT A RED LIGHT WHEN VEHICLE #1 PASSED HER ON THE LEFT WITH LIGHTS AND SIRENS ON STRIKING HER VEHICLE. VEHICLE #1 SUSTAINED MINOR DAMAGE ON THE REAR PASSENGER SIDE. VEHICLE #2 SUSTAINED FRONT END DAMAGE ON THE DRIVERS SIDE. NO INJURIES WERE REPORTED OR OBSERVED AT THE SCENE.
