

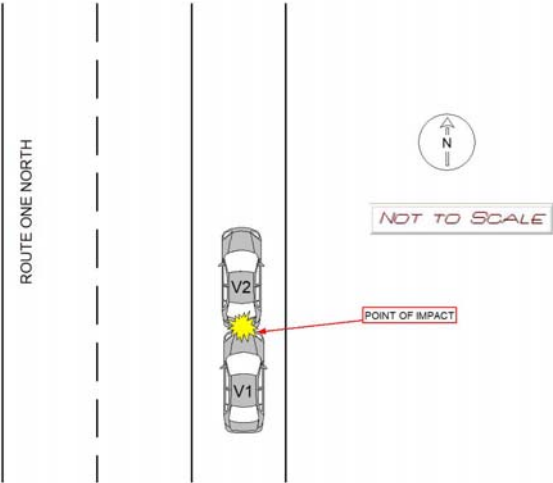

145 Crash Description

THE DRIVER OF VEHICLE #1 STATED IN EFFECT THAT HE WAS TRAVELING NORTH ON ROUTE ONE WHEN V2 CAME TO A SUDDEN STOP. D1 STATED THAT HE WAS UNABLE TO STOP AND STRUCK THE REAR OF V2.

THE DRIVER OF VEHICLE #2 STATED IN EFFECT THAT HE WAS TRAVELING NORTH ON ROUTE ONE. D2 STATED THAT AN ACCIDENT HAD OCCURRED IN FRONT OF HIM SO HE BEGAN TO STOP AND V1 THEN STRUCK THE REAR OF HIS VEHICLE.

NO INJURIES. V1 WAS TOWED DUE TO DISABLING DAMAGE. V2 SUSTAINED MODERATE DAMAGE.

V1 WAS DETERMINED AT FAULT AND RECEIVED A SUMMONS.
