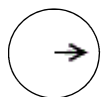


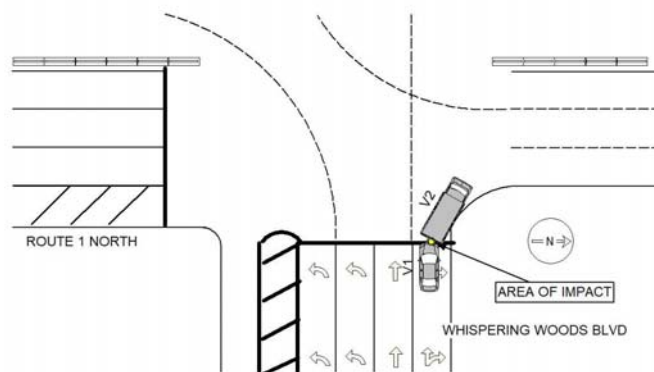

145 Crash Description

D1 STATED IN EFFECT THAT V1 WAS STOPPED AT THE TRAFFIC LIGHT ON WHISPERING WOODS BOULEVARD AT THE ROUTE 1 INTERSECTION. D1 FURTHER STATED THAT SHE BELIEVED V2 WAS MAKING A RIGHT TURN ONTO ROUTE 1 NORTH BUT V2 STOPPED AND V1 STRUCK THE REAR BUMPER OF V2.

D2 STATED IN EFFECT THAT V2 WAS STOPPED AT THE TRAFFIC LIGHT ON WHISPERING WOODS BOULEVARD AT THE ROUTE 1 INTERSECTION. D2 FURTHER STATED THAT SHE BRIEFLY ACCELERATED V2 TO MAKE A RIGHT TURN ONTO ROUTE ONE NORTH BUT HAD TO STOP BECAUSE OF TRAFFIC ON ROUTE ONE NORTH. D2 STATED THAT V1 THEN STRUCK THE REAR BUMPER OF V2.
