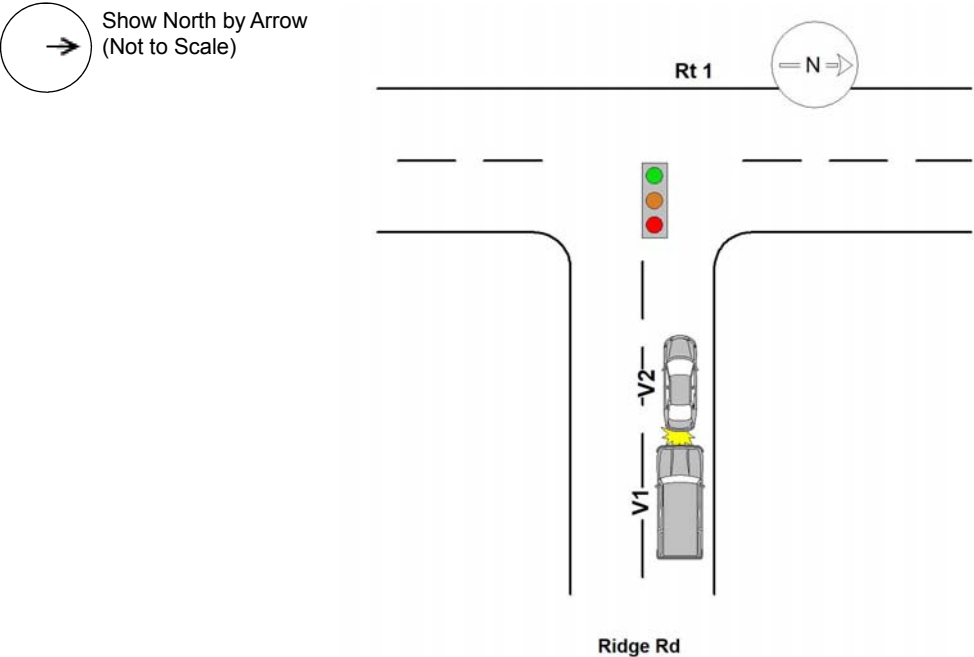

**D1 STATED IN EFFECT, THAT SHE WAS TRAVELLING WESTBOUND ON RIDGE RD APPROACHING THE LIGHT AT RT 1 NORTHBOUND WHEN SHE SPILLED COFFEE ON HERSELF. AS A RESULT HER FOOT SLIPPED OFF THE BRAKE AND HER VEHICLE IMPACTED THE REAR OF V2 WHICH WAS STOPPED FOR THE RED LIGHT.**

**D2 STATED IN EFFECT, THAT HE WAS STOPPED FOR THE RED LIGHT ON RIDGE RD AT RT 1 NORTHBOUND WHEN SUDDENLY HIS VEHICLE WAS IMPACTED IN THE REAR.**

**MY INVESTIGATION REVEALED THAT D1 WAS AT FAULT. HER FOOT SLIPPED OFF THE BRAKE AND AS A RESULT HER VEHICLE (V1) IMPACTED THE REAR OF V2.**
