

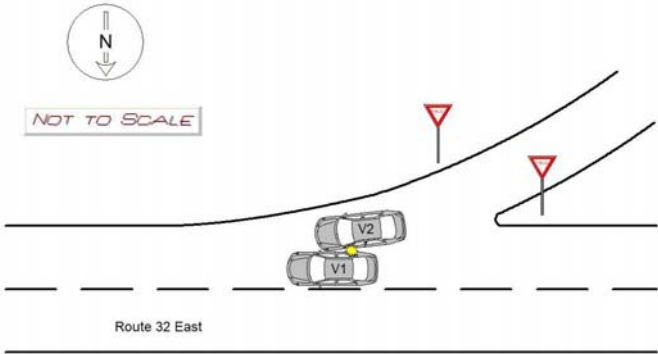

145 Crash Description

DRIVER #1 STATED IN EFFECT WHILE TRAVELLING EAST ON ROUTE 32, VEHICLE #2 FAILED TO YIELD WHEN ENTERING ROUTE 32 CAUSING VEHICLE #2 TO STRIKE VEHICLE #1.

DRIVER #2 STATED IN EFFECT WHILE MERGING TO ENTER ROUTE 32 EAST, THEY DID NOT SEE THE YIELD SIGN AND MERGED INTO TRAFFIC CAUSING VEHICLE #2 STRUCK VEHICLE #1.

DRIVER #2 IS AT FAULT FOR FAILING TO YIELD TO ONCOMING TRAFFIC WITH THE RIGHT OF WAY.

NO REPORTED INJURIES.
