

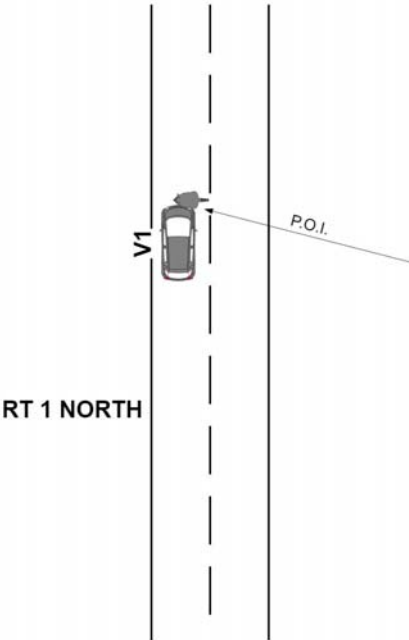

V1 STRUCK A RACCOON ON RT 1 NORTH.

D1 STATED HE WAS DRIVING NORTH ON RT 1 WHEN A RACCOON RAN ACROSS THE ROAD IN FRONT OF HIS VEHICLE. D1 TRIED TO SLOW DOWN IN TIME BUT COULD NOT AND STRUCK THE ANIMAL. THERE WAS SIGNIFICANT DAMAGE TO THE FRONT BUMPER AND RADIATOR OF V1.
