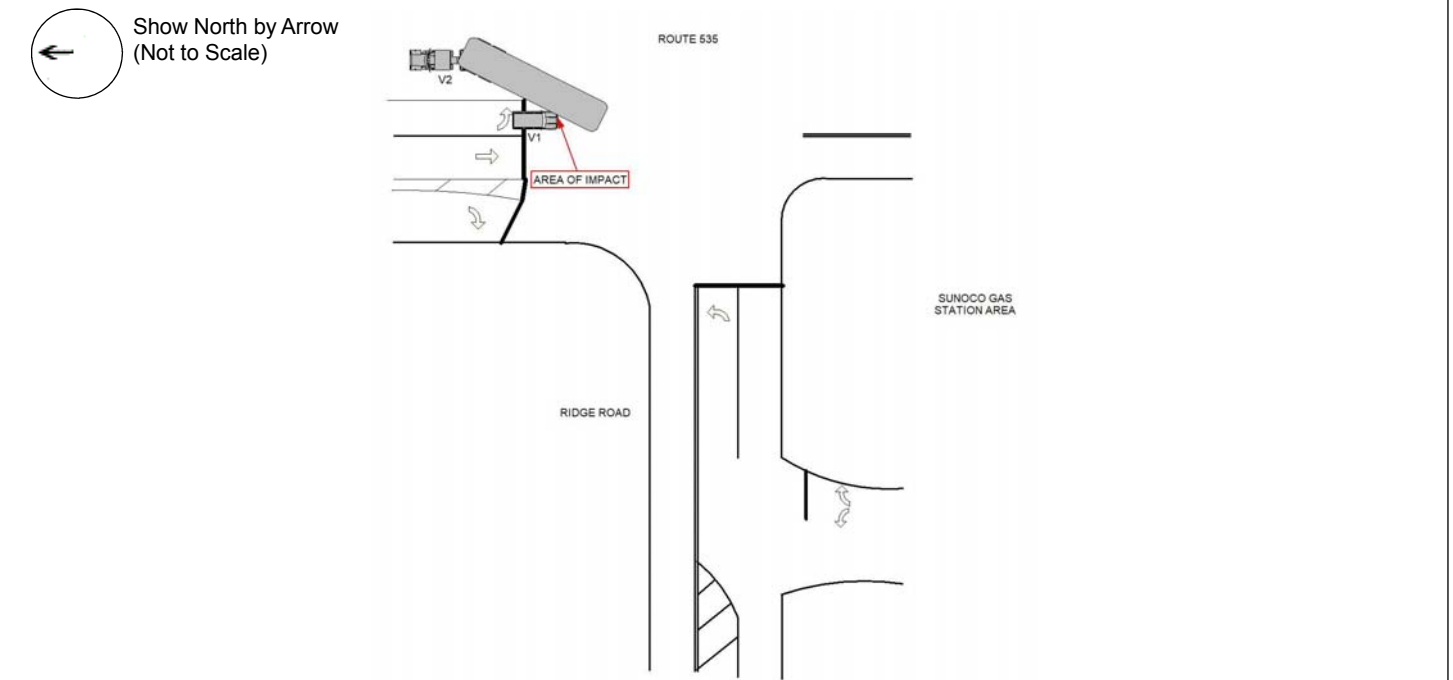

145 Crash Description

D1 STATED SHE WAS STOPPED IN THE LEFT TURN LANE ON RT 535 SOUTHBOUND AT THE INTERSECTION OF RIDGE ROAD. SHE STATED THE LIGHT HAD JUST CHANGED FROM RED TO GREEN AND SHE BEGAN TO "INCH FORWARD". SHE STATED AS SHE WAS INCHING FORWARD, V2 INITIATED A LEFT TURN FROM RIDGE ROAD ONTO RT 535 NORTHBOUND. SHE STATED DURING THE TURN, THE TRAILER OF V2 IMPACTED HER VEHICLE.

D2 STATED SHE WAS MAKING A LEFT TURN FROM RIDGE ROAD ONTO RT 535 NORTHBOUND. SHE STATED AS SHE WAS MAKING THE TURN, THE REAR OF HER TRAILER IMPACTED V1. D2 NOTED THAT V1 WAS NOT BEHIND THE WHITE LINE FOR THE LEFT TURN LANE PRIOR TO THE CRASH.

V1 SUSTAINED DAMAGE TO THE FRONT BUMPER. V2 SUSTAINED DAMAGE TO THE DRIVER'S SIDE REAR TRAILER TIRE. NO INJURIES WERE REPORTED. GEORGES RESPONDED TO THE SCENE AND REMOVED V1.
