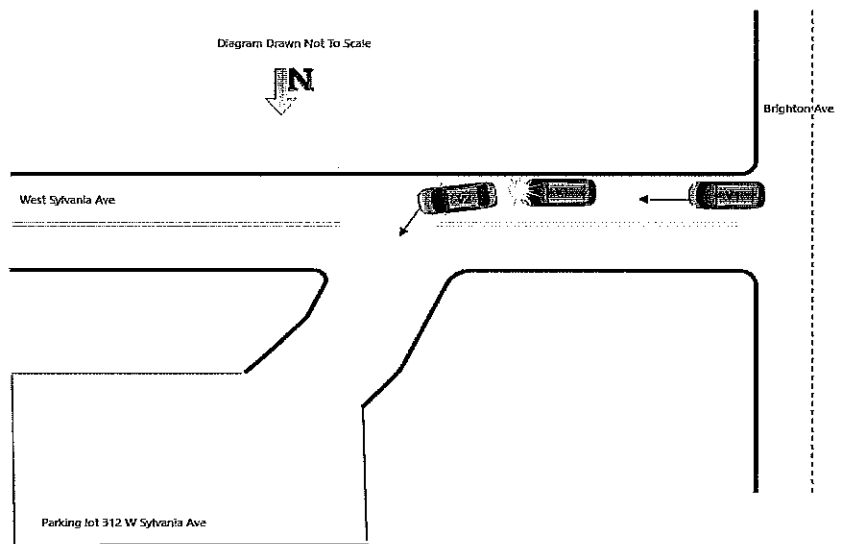

145 Crash Description/Narrative

Box 118A: Driver #1 advised he took his eyes off the road and did not see Vehicle #2 ahead of him.

Vehicle #1 was travelling east bound on West Sylvania Ave. Vehicle #2 was directly in front of Vehicle #1, stopped in traffic waiting to make a left turn into the parking lot of 312 West Sylvania Ave. Driver #1 admitted he took his eyes off the road and did not see the vehicle in front of him. As a result, the front bumper of Vehicle #1 collided with the rear bumper of Vehicle #2, resulting in moderate/functional damage to both vehicles. No occupants in Vehicle #1 were injured. Driver #2 and Passenger #1 in Vehicle #2 both suffered injuries.

The Avon First Aid Squad responded to treat the occupants of Vehicle #2. Driver #2 complained of back pain, however he refused medical attention. Passenger #1 suffered swelling in her face, and complaint of pain in her throat. First Aid transported the patient to Jersey Shore University Medical Center.

Driver #1 was issued summons #1335 E20 000 620 for careless driving (39:4-97). Both vehicles were able to be driven away.
