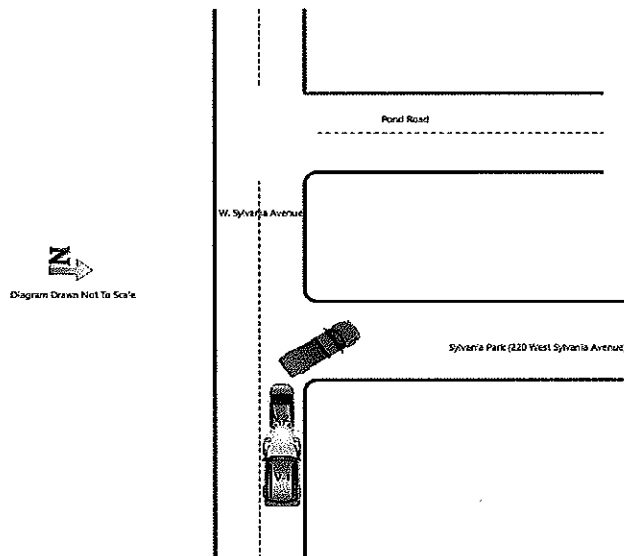

145 Crash Description/Narrative

Box 118B: Driver 1 advised she was slowing down as a vehicle was turning right into Sylvania Park. Driver 1 said she did not see Vehicle 2 slowing down.

Vehicle 2 was traveling west on West Sylvania Avenue. Vehicle 1 was behind Vehicle 2 also traveling west on West Sylvania Avenue. Vehicle 2 began to slow down as a vehicle that was traveling ahead of it was slowing down to make a right turn into Sylvania Park, located at 220 West Sylvania Avenue. Vehicle 1 failed to stop before striking the rear bumper of Vehicle 2, causing minor damage. Vehicle 1 sustained minor damage to its front bumper. All occupants of Vehicle 2 complained of back pain and neck pain. Neptune Township EMS responded and checked all occupants of Vehicle 2. All occupants of Vehicle 2 declined medical attention and stated they would respond to Jersey Shore Medical Center on their own.
