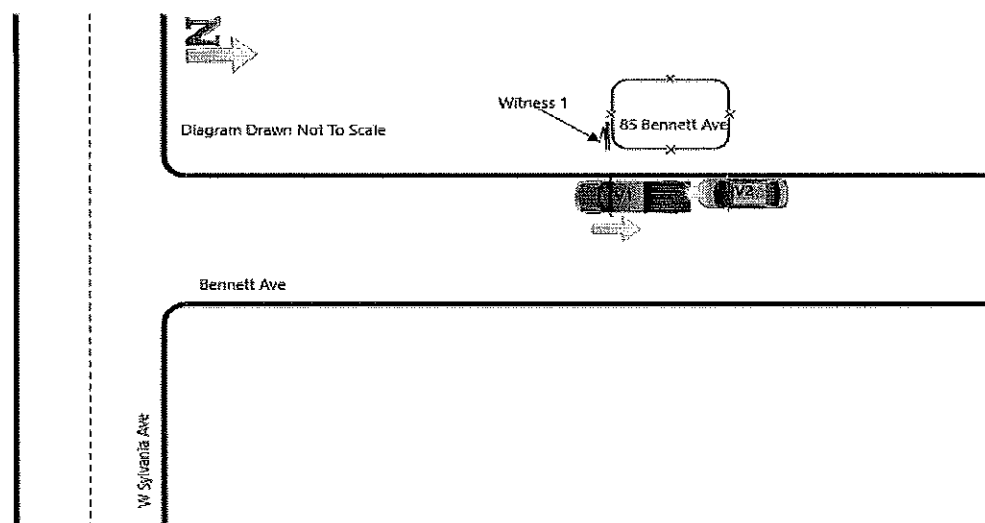

145 Crash Description/Narrative

Witness 1: Edward Shivers; 85 Bennett Ave, Neptune City, NJ 07753 T-(973)-573-8030

Witness 1 stated he observed a white male enter a blue pick-up truck bearing NJ registration E21GYF parked facing south on the west side of Bennett Ave and observed Vehicle 2 parked facing south directly behind Vehicle 1. Witness 1 observed Vehicle 1 back into Vehicle 2, and Vehicle 1 proceeded to drive South on Bennett Ave.

It should be noted prior to this incident, at approximately 5:00 PM, Driver 1 was arrested by NTPD and his vehicle was parked in front of 85 Bennett Ave (reference 20NT17091). I observed Vehicle 1 parked in front of 85 Bennett Ave and I am familiar with Driver 1 from past encounters.

I made contact with Driver 1 via phone who admitted to being parked in front of 85 Bennett Ave, but denied backing into Vehicle 2. I was able to gather Vehicle 1's insurance and attach it to this report.

Vehicle 1 did not sustain any damage according to Driver 1. Vehicle 2 sustained damage to the front bumper. There were no reported injuries.
