

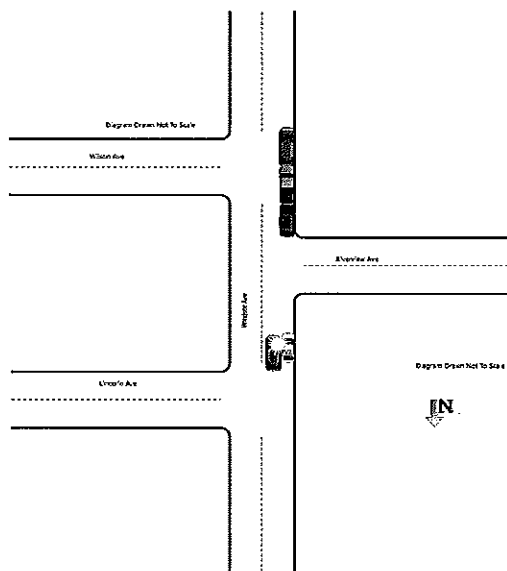

145 Crash Description/Narrative

Witness information- Sean Campbell 109 West Sylvania Ave Neptune City NJ 07753 (908)-433-4173

Box-118A- Driver 1 advised she reached to pick up her cellphone off the floor of her vehicle while driving and briefly took her attention away from the roadway.

Vehicle 1 was traveling south on Windsor Ave. Vehicle 2 was parked on Windsor Ave unoccupied facing south. The Driver of Vehicle 1 stated she dropped her cellphone while driving and attempted to pick it up. While picking up her phone, the front passenger side fender of Vehicle 1 struck Vehicle 2's front driver side fender. Vehicle 1 sustained multiple scratches to the passenger side of the vehicle. Vehicle 2 sustained multiple scratches to the front driver side fender and the drivers side view mirror was knocked off. A witness to the incident advised after Vehicle 1 struck Vehicle 2, vehicle 1 continued south on Windsor Ave in a careless manner before gaining control of the vehicle nearly striking 3 other vehicles before coming to a stop. Vehicle 1 then proceeded to turn around and left their name and phone number on the windshield of vehicle 2 and left the scene without speaking to the vehicle owners or contacting the police. The witness was able to provide patrols with a NJ License plate# M63GLR and a vehicle description of a Honda Accord grey in color. The witness also described the driver of the vehicle as a white female with dirty blonde hair wearing a neon orange cover.

Patrols were able to make contact with the driver of vehicle 1 at her residence and retrieved her driving credentials. It should be noted, upon patrols arrival the driver openly admitted being involved in the accident. No injuries were reported by Driver 1 and no additional property damage was reported.
