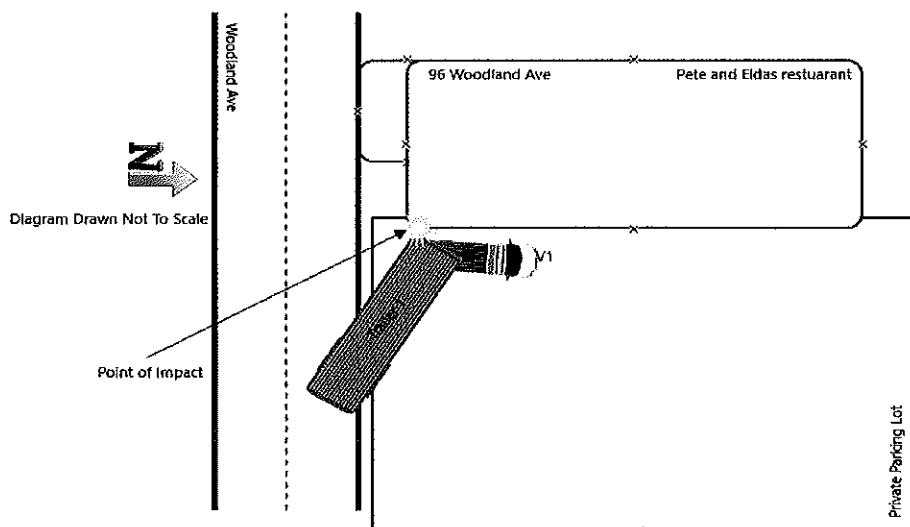

**Box #25 - ACE American insurance Co. 0487**

**Box #118a - Driver 1 misjudged the distance between the top of the trailer and the building.**

**Box #126a - Pete and Elda's Restaurant, 96 Woodland Ave, Neptune City, NJ.**

**It should be noted, Vehicle 1 was towing a 2011 Kidron Trailer bearing MN registration 8099STR and will be referred as Trailer 1. Trailer 1 is an enclosed tractor trailer.**

**Driver 1 was advised by a Pete and Elda's Restaurant Employee to park the trailer in the loading area and not in the parking lot. Driver 1 stated he would not be able to fit his vehicle in the loading area and proceeded to park in the 96 Woodland Ave parking lot. Vehicle 1 was traveling west in the parking lot and making a right turn, now traveling north. Vehicle 1 made a sharp right turn too close to the building, resulting in the front driver-side corner of Trailer 1 to strike the south eastern corner of the building, damaging the gutters and siding. No structural damage was observed.**

**Trailer 1 sustained damage to the top front driver-side portion of the trailer. The building sustained damage to the south eastern corner. There were no reported injuries.**
