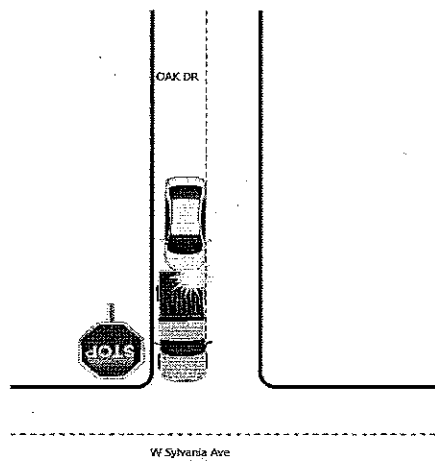

145 Crash Description/Narrative

Box #118a - Driver #1 did not provide enough stopping distance between Vehicle #1 and Vehicle #2, while Vehicle #1 was behind Vehicle #2.

Vehicle #1 was stopped in traffic on Oak Dr behind Vehicle #2. Vehicle #2 was stopped in traffic on Oak Dr at the posted Stop Sign for Oak Dr traffic, at the intersection of W Sylvania Ave. Vehicle #2 began to drive forward (south) but stopped due to W Sylvania Ave traffic. Vehicle #1 began to drive forward (south), but was not able stop immediately and the front of Vehicle #1 collided with the rear of Vehicle #2; approximately 15 feet north of W Sylvania Ave.

Both vehicles sustained damage to their respective points of impact; Vehicle #1 sustained moderate damage and Vehicle #2 sustained minor damage. Neither Driver or the Passengers complained of any pain or injuries while on scene. It should be noted the Passenger of Vehicle #2 later responded to Jersey Shore University Medical Center with a complaint of head pain.
