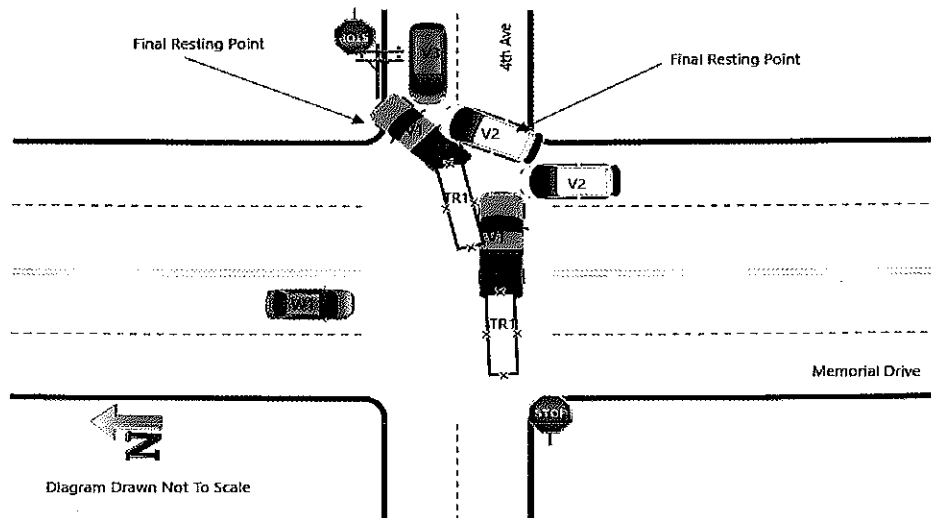

Box #55 - Pennsylvania Financial Responsibility Identification Card (All State)**Witness 1: Elizabeth Huttner - 300 Cookman Ave, AP, NJ 07712 - 609-712-3737**

Witness 1 stated she was driving south on Memorial Dr and observed Vehicle 1 traveling east on 4th Ave, and failed to stop at the stop sign. Witness 1 slammed on her breaks, and observed Vehicle 1 collide with Vehicle 2. A driver witness statement form was completed and attached to this report.

Vehicle 1 was traveling east on 4th Ave and towing a trailer bearing NJ registration TWV23P, approaching the Memorial Dr/4th Ave intersection. Vehicle 2 was traveling north on Memorial Dr in the right hand lane. Vehicle 3 was traveling west on 4th Ave and stopped at a stop sign. Vehicle 1 proceeded to enter the intersection without yielding to traffic or stopping at the stop sign and struck Vehicle 2. Vehicle 1 proceeded to drive forward and struck the front end of Vehicle 3, then struck a utility pole (JC108NC) and came to a halt in the roadway. The utility pole did not sustain any damage.

Vehicle 1 sustained damage to the front bumper of the vehicle. Vehicle 2 sustained disabling damage to the front end and towed by Bennett's towing. Vehicle 3 sustained damage to the front bumper of the vehicle.

NCFD responded and cleaned the fluid. Driver 1 had a complaint of pain to his head. Driver 2 had a complaint of pain in his chest. NTFA responded and evaluated both drivers, who refused further medical treatment, and would seek medical help after the incident.
