145 Crash Description/Narrative

Box 25 - **Out of State Insurance - Old Republic Insurance Co. (307 North Michigan Avenue, Chicago IL, 60601)**

Box 118a - Driver Inattention - While the driver was parking in the bay of Platinum Car Wash, he did not observe the slight incline on the blacktop before entering.

Box 126b & 126e - Fixed Object - Hose Nozzle

Box 128 - Fixed Object - Hose Nozzle

The driver of Vehicle #1 pulled into Platinum Car Wash attempting to get his commercial vehicle washed. When the driver of Vehicle #1 pulled into the car wash, he pulled directly into the bay which said "Commercial Only". While pulling into the bay, it was on a slight incline which could effect the height required to enter the bay. Driver #1 stated that when Vehicle #1 entered into the "Commercial Only" bay the vehicle struck a nozzle connected to a hose on the ceiling. Driver #1 stated after the vehicle collided with the hose it became dislodged. There appeared to be no permanent damage at this time, but the hose remained detached at this time. The nozzle then scraped along the roof of the vehicle causing a "golf ball size hole" in the middle of the roof. It should be noted: The driver of Vehicle # 1 stated he heard a scraping noise on the roof of his vehicle and immediately backed out of the bay. Due to the height of Vehicle #1, the driver was unable to assess the damage at this location. The driver then left the scene and returned approximately one hour later and notified patrols.

No injuries were reported, and moderate damage was done to the roof of the vehicle.
