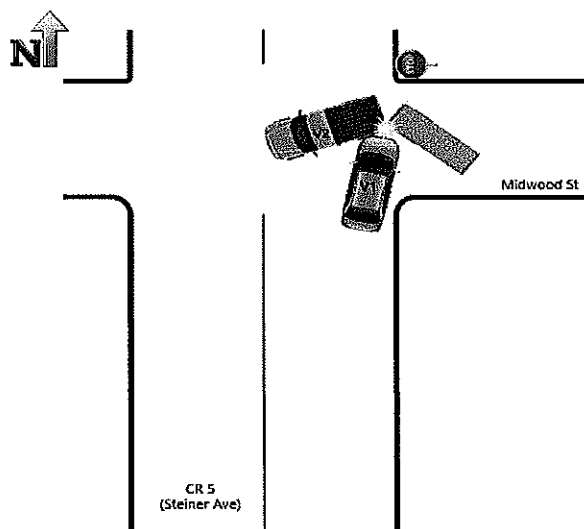

145 Crash Description/Narrative

V1 was traveling north on CR 5 (Steiner Ave). V2 was traveling west on Midwood St, and stopped at the intersection of CR 5 and Midwood St, at a posted stop sign (It should be noted, V2 had a large landscaping trailer attached to the back, NJ Reg: TVC87S). D2 began to enter the intersection before it was clear, in order to make a left hand turn onto CR 5. V2 pulled out directly in the path of V1, who was unable to stop in time. The front of V1 collided with the driver's side rear fender of V2.

There was disabling damage to both vehicles. V1 had multiple airbag deployments, and a check of the driver's seatbelt showed it to be locked in the up position, indicating D1 was not wearing his seatbelt at the time of the crash. There was also a spidering of the windshield in line with the driver's seat, which most likely was caused by D1 impacting the windshield. D1 was transported to JSUMC by NTFAS with a possible concussion.

There were no other reported injuries. Both vehicles were towed from the scene (V1 by Jim's Towing, V2 by Taylor's Towing; the trailer was left on scene at the owner's residence.) NCOEM responded for fluid leaks from V1.

D1 received Summons E20 1112 for Failure to Wear Seatbelt. D2 received Summons E20 1111 for Failure to Stop or Yield.

It should be noted, a witness (Harry Conover, Jr; 77 Steiner Ave) advised he saw V1 prior to impact traveling north on CR 5 at a high rate of speed.
