Box #25 - Westchester Fire Insurance Company NAIC #10030**Box #118A - Driver 1 was driving in an area where no Trucks over four tons are allowed to drive.****Box #126B - Curb-line Grass**

It should be noted vehicle 1 was towing a Star Leasing Company Trailer bearing Maine registration 38-11680. It should also be noted, Lincoln Ave and Windsor Ct are listed as areas where no trucks over four tons are permitted to drive, Local Ordinance 129-29.

Vehicle 1 was traveling West on Lincoln Ave and making a right turn onto Windsor Ct, traveling to TFH Publications. While making the right turn, Vehicle 1 struck the western curb, and the front tires of Vehicle 1 damaged the curb-line grass area of 29 Windsor Ct. Vehicle 1 proceeded to complete the turn and park in the TFH Publications parking lot.

The curb-line grass of 29 Windsor Ct was damaged. There was no damage to Vehicle 1 and no reported injuries.
