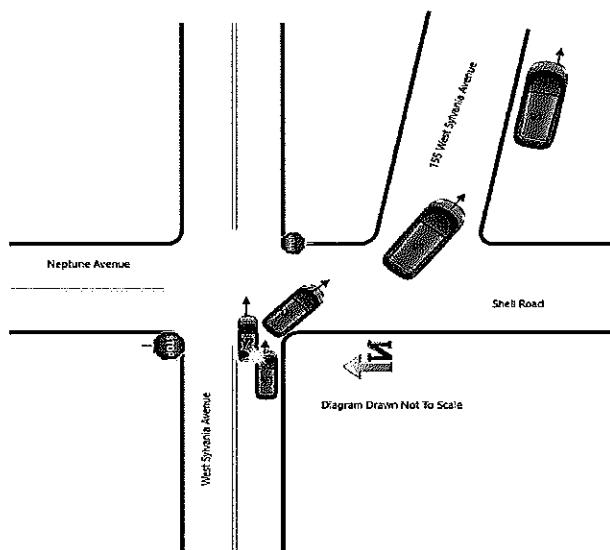

145 Crash Description/Narrative

118a: Driver 1 stated Vehicle 2 stopped short and he stepped on the clutch instead of the brakes.
126b: Vehicle 1 drove onto the grass of 155 W Sylvania Avenue after colliding with Vehicle 2

Vehicle 2 was stopped behind a vehicle, facing east, making a left turn onto Neptune Avenue from West Sylvania Avenue. Vehicle 1 was travelling behind Vehicle 2. Driver 1 stated he went to step on his brakes, because Vehicle 2 was stopping short, and he stepped on the clutch instead of the brake. Driver 2 stated she was stopped in traffic.

The front driver side fender/bumper of Vehicle 1 collided with the rear passenger side fender of Vehicle 2. Vehicle 1 continued to travel onto Shell Road, and then onto the grass next to the driveway of 155 West Sylvania Avenue.

Driver 1 backed out of the grass and parked his car on Shell Road. I observed both of his front tires were flat and fluid leaking from it. Vehicle 2 had a dent and scratches on the rear passenger side bumper.

No injuries were reported and both drivers stated they did not need medical attention.

Bennett's Towing responded and towed Vehicle 1. Neptune City Office of Emergency Management was dispatched and responded for the fluid leak.
