145 Crash Description/Narrative

Vehicle #1 was backing in a Westerly direction from a marked parking space in the parking lot of 311 W Sylvania Avenue (Brighton Arms II). **Vehicle #2** was traveling in a Southern direction in the parking lot of 311 (Brighton Arms II). While backing, the rear of **Vehicle #1** collided with the right front fender and door panel of **Vehicle #2**. Both **Vehicle #1** and **Vehicle #2** sustained significant damage to their respective points of impact.

The driver of **Vehicle #1** did not report any injuries or have complaints of pain at this time. The driver and passengers of **Vehicle #2** also did not have any injuries or complaints of pain. Both **Vehicle #1** and **Vehicle #2** were able to be driven from the scene.
