

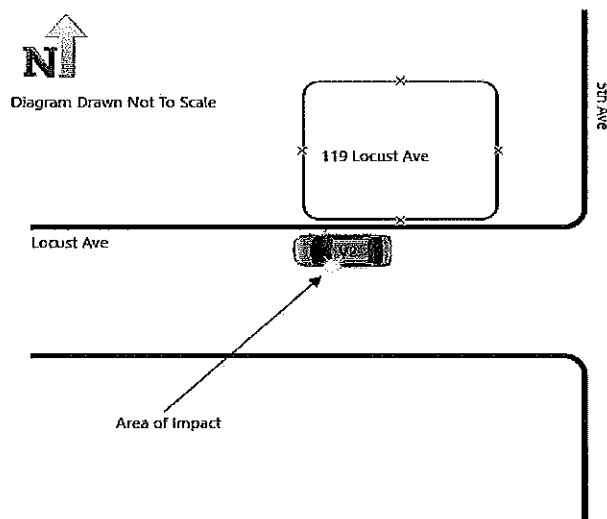

145 Crash Description/Narrative

The Owner of Vehicle 2 (Owner 2) stated she returned home at approximately 5:00 PM on 9/8/20 and parked Vehicle 2 on the West side of Locust Ave, facing South. At approximately 8:30 PM, Owner 2's male neighbor (who possibly resides at 118 Locust Ave and believed to be Julio Ortega) responded to her address and advised her, his brother had struck her vehicle. Owner 2 was provided the brothers name, Ed, and a phone number, 732-619-7350. Owner 2 observed damage to her front driver-side door. Owner 2 attempted to contact Ed, but was unable to.

Patrols attempted to make contact with the Ortega via phone, 732-807-3686, as well as going to his residence, but we were unable to make contact with him. Patrols made multiple attempts at contacting Ed via phone, but were unable to. Owner 2 was advised to contact NCPD if she makes contact with Ortega or Ed.
