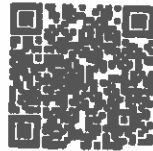

I, Richard Hone, duly of age, depose and say;

I know this court has no idea how much this topic has been covered ad nauseum with the exact same answers I will give this court now, so I will reiterate what I have stated in the past.

This is my Sworn Statement in response to the 1-23-2023 Order by Judge Thomas W. Sumners Jr. C.J.A.D.

Question:

"Provide complete documentation regarding the trust established for his daughter"

Answer:

I have no information on this trust as all the prior testimony states. I have nothing to do with it, am not involved in any way, I do not benefit in any way, I have no idea how much or how little is in there, and I do not know who the officer(s) are. The only time I inquired about this in late 2016 and before the original principal passed away a couple of years later it did not have anything significant in it by any means (Details about this in "history and purpose" below)

Question:

"whether appellant has access to the principal of the trust"

Answer:

NO

History and Purpose of Trust:

On January 20, 2015 my first child [REDACTED] was born at 8:08am which I can state unequivocally was the Greatest Day of My Life.

Three days later the mother started a custody fight of epic proportions that continues to this day unabated because I called the police and DCF on her dominatrix/prostitution business because her "dungeon" was in the same apartment as where [REDACTED] her then 6-year-old child from her 2nd marriage, also lived.

I found it unbelievable that someone would put a child at risk like that. We never had a good relationship.

I met this woman 5 days before my mother passed away after a 9-year illness that cost me and my mother almost one million dollars for her private care. At the time of my mother's death on September 3, 2013 I had very little money left except for the condo in Edison. I found out the respondent was a convicted child kidnapper and child abuser after she got pregnant, but did my best to make the best of things for the sake of our daughter. She had no intention of doing anything good or right for my daughter.

I was then Blackmailed into signing a completely one-sided custody agreement I never in a million years would have signed had I been in my right mind or being shaken down to do anything she wanted in exchange giving her sole-custody.

I was completely blindsided by her move to take and keep my little girl away from me at all costs, and relapsed in March 2015 and by the end of March 2015 I was drinking daily (I have 7 years, 6 months and 29 days sober today).

Meeting this woman also cost me over 3 years of my freedom and caused me to also almost lose my life in the battle of Aleppo, Syria.

During the time [REDACTED] was born and before I went to Mexico, I had been planning my last Human Rights mission, and had zeroed in on Aleppo, Syria because I was familiar with the brutal dictatorship of Bashir Al Assad through some long-time friends of mine who are Ex Senior Level CIA Officers from the Elite Clandestine Services, and people I had worked with in the past on Human Rights missions at the U.N. and other NGO's.

I also had a very very Bad Feeling I was going to die there, in Alepppo, and that my daughter would only know and hear the good things about me.

That prophecy almost came true.

THAT is why I just handed over everything I had except for some money for what I assumed would be about 6 months in Mexico.

THIS is why I have no knowledge of my daughter's trust, who runs it, why I have no access to it or to anyone who is involved because I do not know anything about it, nor will I ever.

I can't stress enough to this court that I am 100% disabled primarily from the 8 athletic and other surgeries I have endured, and the anxiety and depression I suffer will only get better according to the doctor when my custody case resolves in [REDACTED] best interest, which when dealing with someone with the past (including the [REDACTED] she has, looks like there will never be an end in sight until [REDACTED] turns 18.

I think the court gets the gist of why this is something I have nothing to do with, have no knowledge of, don't care, and that my Sole Purpose in Life is to raise [REDACTED] as a Christian and to know Jesus, and to get back to work at some point and provide for her like I have always intended to do, which is to own her own home outright, and leave her financially secure, which will never happen unless the mother stops abusing [REDACTED] and doing everything in her power to destroy my life and [REDACTED] life along with it.

I swear the above statements made by me are true. If any of the foregoing statements made by me are false, I am subject to punishment.

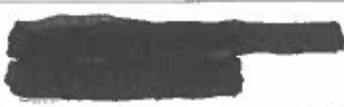

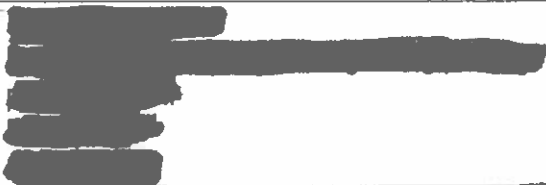
