Supplement

On the above date and time, I, Ptl. Miserendino #285, responded to 149 Brindletown Road for an officer request. The call was placed to Ocean County Dispatch by a third-party caller, Danielle Watkins, who reported that Tina Vega and Roy Vega had placed an additional lock on the property gate, preventing access to an employee, Olivia Miller.

This has been an ongoing issue involving the Plumsted Township Police Department and marks the third such incident since May 14, 2025. On that date, I previously advised Mr. and Ms. Vega that they are not permitted to block access to the property, as there is no active court order barring Mr. Watkins or his employees from entry.

I attempted to make contact with both Mr. and Ms. Vega, as well as the property owner, Albert Canka, but was unsuccessful. Ocean County Dispatch also attempted to reach Ms. Vega without success.

Due to the obstruction, I used bolt cutters to remove the wire securing the gate to restore access. The entire incident was recorded on my body-worn camera. No further police action was taken at this time.
