Supplement

On the above date and time I Sgt. Garrigan #273 and Ptl. Briody #299 responded to 149 Brindletown Rd for a report of a female employee locked in the property. Upon arrival we met with Maura Fields who was unable to exit the farm due to the main gate and side gate being locked with a pad lock. Ms. Fields was on the phone with her employer, Danilee Watkins at the time she arrived and asked if I would speak with him. I spoke with Mr. Watkins at this time who informed me that the gates were locked again by the property managers Tina and Roy Vega. Mr. and Mrs. Vega as well as the owner of the property (Albert Conka) were informed the day before by Ptl. Miserendino and Ptl. Chelston that they can not lock Mr. Watkins out of the property without proper court documents (see incident #25PM07294).

Ptl. Briody and I attempted to make contact with Mr. and Mrs. Vega by calling both of their phones which was unsuccessful. Ptl. Briody and I then tried to make contact with both parties at their residence by knocking on their door and ringing their doorbell which we were also unsuccessful. At this time I had Ptl. Briody stay on scene while I went back to headquarters to get bolt cutters to open the gate.

Chief Meroney #257 contacted Ocean County Superior Courts at approximately 1600 hours to see if a ruling was made about the eviction of Mr. Watkins. Chief Meroney was informed that no decision was made and the hearing was rescheduled for a later date TBD. Chief Meroney then contacted Mr. Conka and told him the gates to the farm were locked again and there was a Greencell farms worker inside. Mr. Conka stated that he would try to contact someone at the farm to have them open the gate. Mr. Conka called back later and stated he was unsuccessful in making contact with anyone on premise and gave permission for officers to cut the locks.

I Sgt. Garrigan #273 responded back out to 149 Brindletown Rd and met with Ptl. Briody and Mrs. Fields. I was successful in gaining access to the farm by cutting the chain on the gate. Mrs. Fields was able to leave the property without issue. At this time I returned to headquarters and contacted Mr. Watkins as he requested. Mr. Watkins wanted to let officers know that he believes Mr. Conka as well as Mr. and Mrs. Vega are plotting against him to make sure he gets charged by officers. Mr. Watkins also wanted to know if he is able to access the front main gate of the property. I advised Mr. Watkins that according to Honorable Judge Sahin, as long as his agreement with Conka Farms states that he is allowed access to the gate and there is no other order barring him from accessing it then he can use it. Mr. Watkins understood and had no other issues at this time.

After speaking with Mr. Watkins I completed a summons for Tina Vega and charged her with 2C:33-11.1 (Certain actions relevant to evictions, disorderly persons offense). Due to officers being unable to make contact with Mrs. Vega, the summons was certified mailed to her address.
