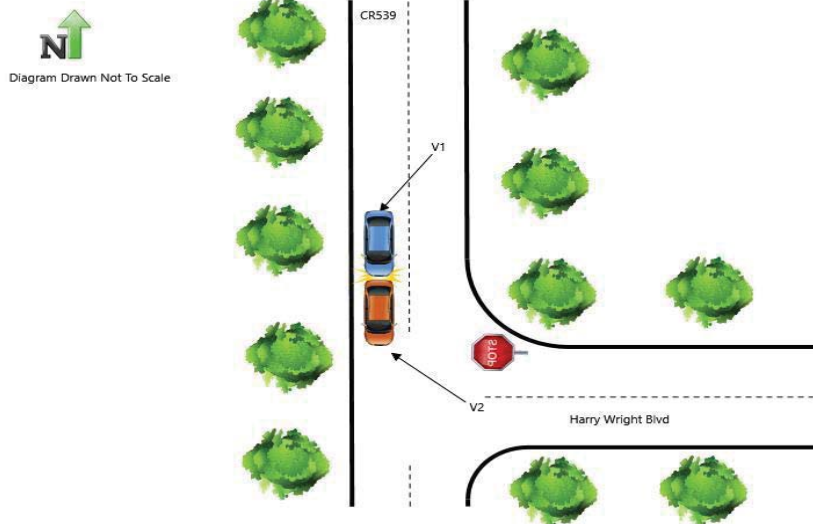

145 Crash Description/Narrative

Driver 2 stated she was stopped in roadway on County Route 539 at the intersection of Harry Wright Blvd with her left turn signal activated. Driver 2 stated she was waiting to make a left turn onto Harry Wright Blvd when her vehicle was impacted in the rear by Vehicle 1.

Driver 1 stated he was traveling south on County Route 539 near the intersection of Harry Wright Blvd when he observed Vehicle 2 in front of him. Driver 1 stated as he approached Vehicle 2, he realized Vehicle 2 was stopped in the roadway without a blinker on. Driver 1 advised he did not have enough time to react and impacted the rear of Vehicle 2.

Witness Statement: Mathew Richardson, a witness to the crash stated he observed Vehicle 2 stop quickly to make a left turn at the intersection of County Route 539 and Harry Wright Blvd when Vehicle 1 impacted Vehicle 2 in the rear. See attached document.

Officer Conclusion

Driver 1 caused the crash by following too closely to Driver 2. Based on Driver 1 and Mr. Richardson's statements, Driver 2 stopped abruptly prior to the crash. Based on the statements of all parties involved, there are conflicting reports of Driver 2 activating her left turn signal. All above listed parties sustained injury during the crash. Mr. and Mrs. Santilli were transported to Community Medical Center. Ms. Maurer was transported to Jersey Shore University Medical Center. Both vehicles sustained disabling damage and were towed from the scene by Priced Rite Towing. Driver 1 was issued a traffic summons for Careless Driving 39:4-97.
