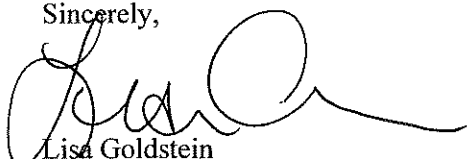
Re: Open Public Records Act Request

Therefore, the requested record cannot be released and there was no unlawful denial of access").
