Administration, Governing Body and Construction;

Just want to make sure you are aware of ongoing problems at 213 East Main Street.

The fire department has answered multiple fire and EMS calls there. A number of fire alarms are due to the apparent fact that detectors are located in areas that would not normally have them if designated as a residential property. This means that such activity as cooking and smoking will trip the alarms. We also have had multiple issues with residents shutting off alarm prior to fire department arrival.

We are told that this property is supposed to be commercial, but instead has been illegally put into use as a residential property.

Hopefully, if the building is not in compliance, things are rectified quickly. Our worry is that the Borough of Tuckerton could have a big liability exposure should someone get hurt or killed as a result of a fire call there.

From a fire department standpoint, the numerous unnecessary alarms there can cause members to stop responding as it is a waste of time.
