He noticed mouse droppings around the apartment, especially in the furnace area, but the hotspot was significant rodent activity behind the dishwasher, where he found a huge hole and significant droppings.

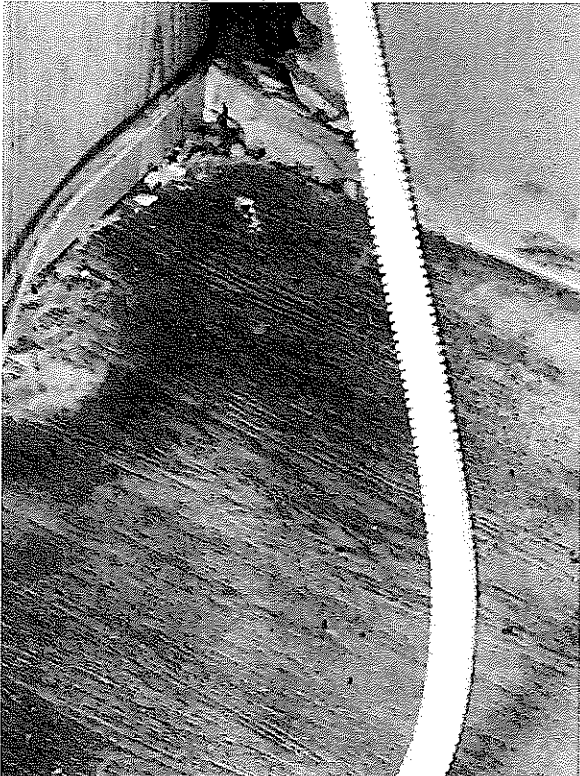

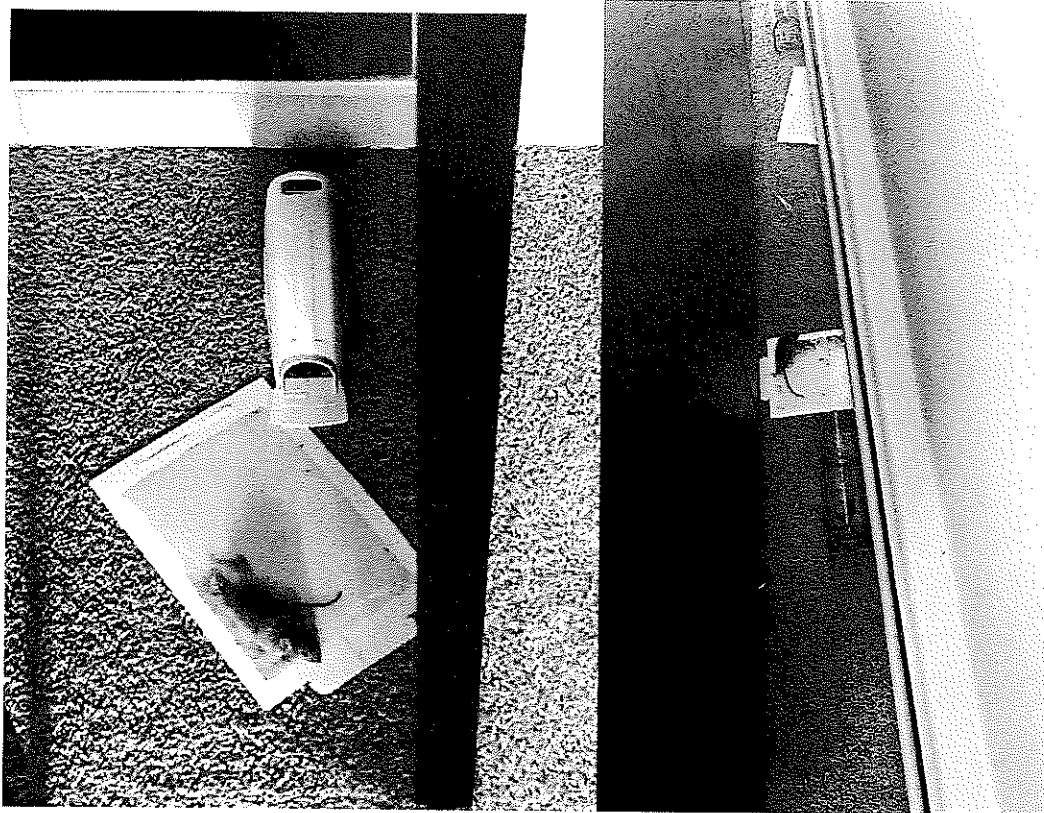

4. Cover expenses related to moving into new accommodations.

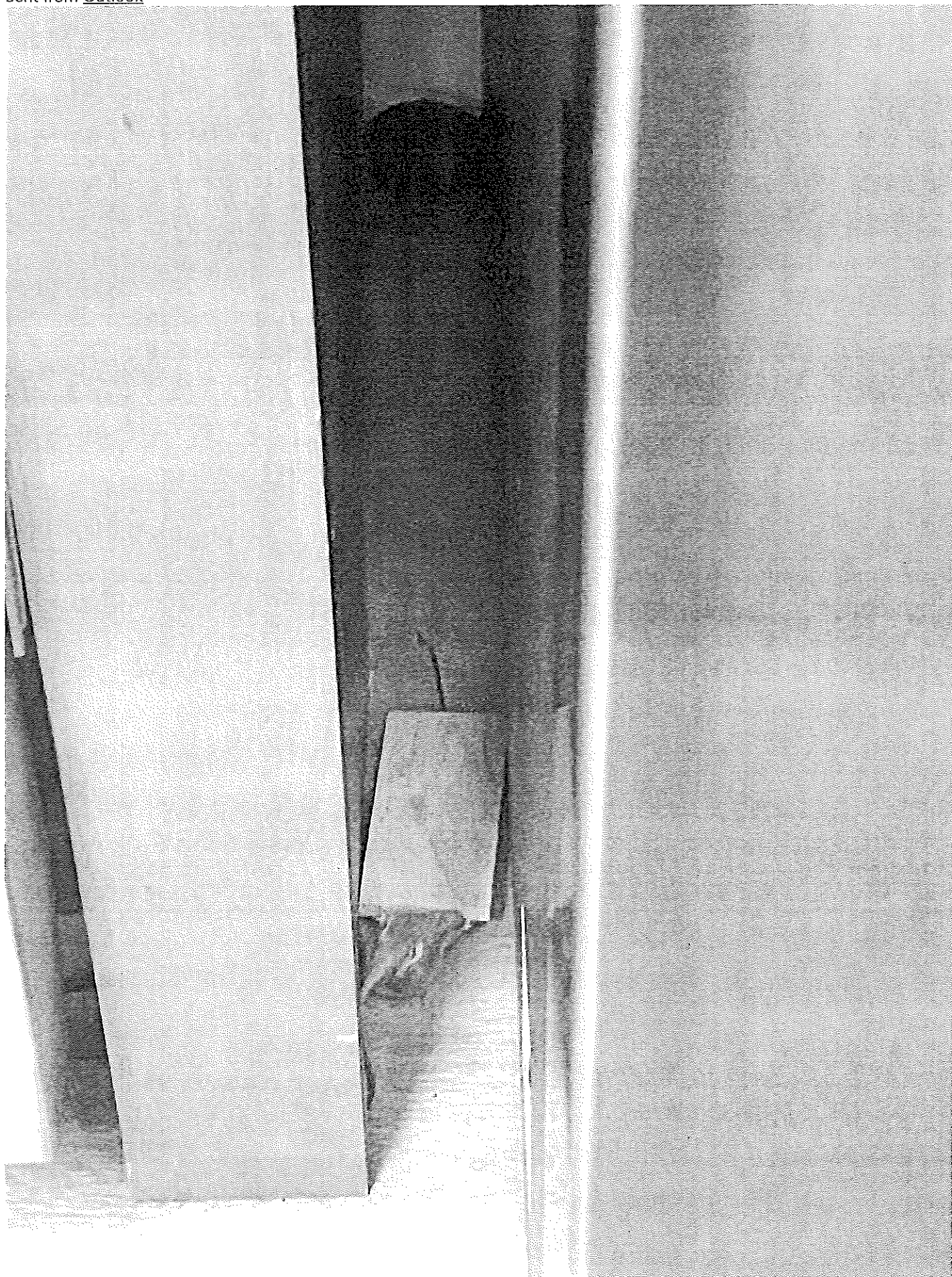

4. Coverage for expenses related to moving into a new apartment.

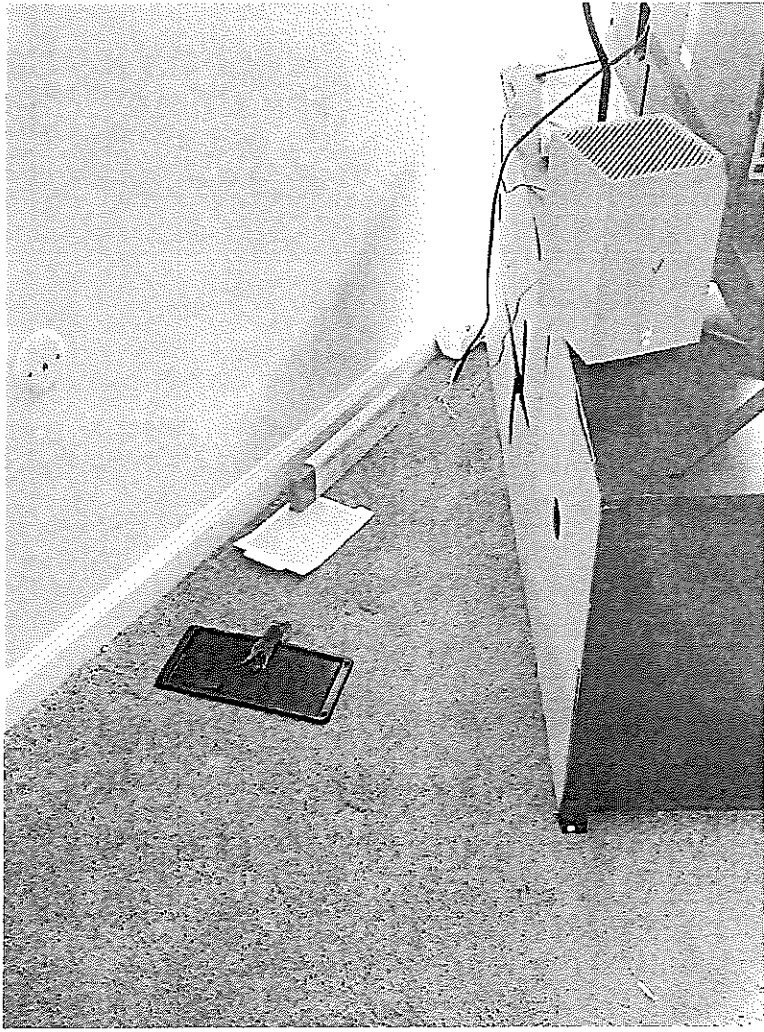
