UPON ARRIVAL WE MET WITH THE RESIDENTS OF BOTH 50 THIEM AVE. AND 54 THIEM AVE. THE RESIDENT OF 50 THIEM AVE. FRANK FURBACHER STATED THAT HIS WIFE WENT TO WALK THEIR DOG IN FRONT OF THE HOUSE. WHEN DOING SO, THE DOG WHO LIVES AT 50 THIEM AVE. GOT OUT OF THE YARD/HOUSE UNLEASHED AND ATTACKED THEIR DOG. THE DOG WAS UNABLE TO WALK ON ITS REAR LEGS AND WAS GETTING TAKEN TO THE ANIMAL HOSPITAL. THE RESIDENTS OF 54 THIEM AVE., SANDRA/THOMAS HICKEY, STATED THAT THEY ACCIDENTALLY LEFT THE SIDE GATE OPEN TO THE BACKYARD WHEN THE DOG GOT OUT UNLEASHED. THEY WERE GIVEN A VERBAL WARNING FOR THE INCIDENT. THE DOG AT 54 THIEM AVE. IS MUCH LARGER THAN THE DOG AT 50 THIEM AVE.. THE DOG BITE REPORT WAS COMPLETED AND SENT OVER TO THE BERGEN COUNTY HEALTH DEPARTMENT. IT WAS LATER FOUND THAT A PREVIOUS DOG OWNED BY THE FURBACHER'S WAS ATTACKED BY THE SAME DOG IN 04/2020. IN THAT CASE, THE DOG FROM 54 THIEM AVE. WAS LET OUT MY MISTAKE AGAIN AND ATTACKED THEIR DOG AS WELL. THEY DID NOT REPORT IT AT THE TIME, AND THE SAME NEIGHBORS AT 54 THIEM AVE. PAID THE VET FEES. ALSO IN 2019, THEY STATED THAT THE SAME DOG CHASED DOWN THEIR MOTHER AND CORNERED HER UNTIL THE NEIGHBOR WAS ABLE TO GAIN CONTROL OF THEIR DOG. **UPDATE AS OF 9/17, THE DOG (VICTIM) FROM THE BITE THAT TOOK PLACE ON 09/16/2022 WAS PUT TO SLEEP AS IT SUSTAINED EXTREME INJURY DUE TO THE INCIDENT.
