Dear Mr. Boud and Ms. Bernokeits;

The purpose of this letter is to advise you that Hazlet Township adopted codes to regulate residential properties. Particularly Chapter 133 of the Codes of Hazlet Township "Animals" which states:

133.2: Licensing of Dogs – No dog of licensing age shall be allowed to be harbored in the Township without being licensed as provided in the following requirements:

1. Annual Registration Required
2. License Fee

133.3: Running at large – No dogs shall run at any time within the limits of the township.

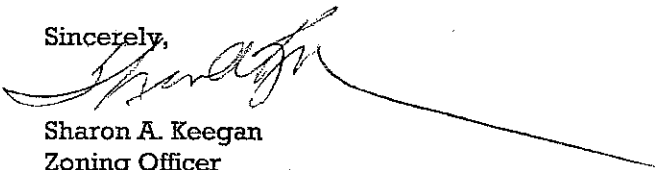
133-4: Leashing of dogs – No person owning a dog or having the care, custody or control of any dog shall suffer or permit such dog to be off the premises owned or in other manner in possession of such person, unless dog is accompanied by a person at least 10 years of age and capable of controlling the dog which shall be on a leash not more than six (6) feet long.

After receiving confirmation that your dog bit a township police officer a review of the files revealed that you do not have your dog licensed. Please contact Mary Lynch 732-264-1700 ext. 8682 to obtain a license.

The ordinance states that you have ten days to abate said violation to avoid further action.

I anticipate your immediate response to obtaining a license for your animal.

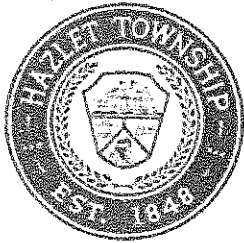
