1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

During the course of a hit & run investigation it was revealed that the accused (Dominique Ellis) intentionally collided her vehicle with the victim [REDACTED] vehicle during a domestic violence incident, then fled the scene. D. Ellis collided her vehicle with [REDACTED] vehicle after observing her boyfriend [REDACTED] riding in the passenger seat along with [REDACTED]. A typed victim statement was provided by [REDACTED]. Note: [REDACTED] later became uncooperative and refused to provide details of the incident. D. Ellis responded to NCPD headquarters where she was advised of her charges, then was transported to Bradley Beach PD for processing.
