NARRATIVE

On January 1, 2023 at approximately 3:31 AM I (Ptl. [REDACTED]) was driving west bound on [REDACTED] in the area of [REDACTED] when I noticed a group of individuals involved in a physical altercation. I stopped my Patrol vehicle and activated my emergency lights in an attempt to disperse the group of people. I informed Rowan Communication of my location and advised them I would be out with the group of people.

After exiting my patrol vehicle, I activated my body worn camera and attempted to disperse the group and I noticed a female had been pushed during the altercation and was laying on the ground. I was able to keep the three individuals who had been fighting to remain on scene until Ptl. [REDACTED] was able to arrive on scene. At that point I attempted to render medical aid to the female, later identified as [REDACTED] Student [REDACTED] who was unconscious but breathing. I notified Rowan Communications to send EMS to evaluate the [REDACTED] While attempting to evaluate [REDACTED] she

stood up and ran towards one of the individuals of the group (later identified as [REDACTED], Student [REDACTED]) and struck him.

At this time [REDACTED] was detained for her actions [REDACTED] was detained for not complying with verbal commands, his aggressive demeanor and for his safety due to his level of intoxication.

EMS arrived on scene to evaluate [REDACTED] at which point she declined any further medical attention. EMS then evaluated [REDACTED] who was beginning to lose consciousness and was vomiting. At this time [REDACTED] was placed on a stretcher and transported to Inspira Medical Center of Mullica Hill for further evaluation.

While speaking with Student [REDACTED] he stated that [REDACTED] was following them and he and [REDACTED] (Non-Student) were attempting to have him leave them and [REDACTED] alone, at which point the physical altercation began.

While on scene a witness, [REDACTED] (Non-student), stated she had witnessed the scene from her apartment in [REDACTED] [REDACTED] stated that she did not see anyone strike [REDACTED] but that she was pushed out of the altercation and hit her head on the pavement.

At this time [REDACTED] and [REDACTED] did not wish to press any charges. I went to Inspira Mullica Hill to follow up with [REDACTED] but was unable to speak with him do to his level of intoxication. A card with contact information was left with [REDACTED] to give his statement when he is able to do so.

At this time Rowan Communications was advised that all units would be clear and that I would be handling the report.

NARRATIVE On January 2, 2023, I (Investigator [REDACTED] of the Rowan University Police Department) was assigned an assault case by DSgt. [REDACTED]. Ptl. [REDACTED] reported in his Initial Incident Report that at approximately 3:31 AM on January 2, 2023, he was driving westbound on [REDACTED] when he observed a group of individuals involved in a physical altercation. After notifying Rowan Communications of his location and the altercation, Ptl. [REDACTED] observed a female, later identified as student [REDACTED], being pushed during the altercation and lying on the ground. Ptl. [REDACTED] was able to keep the three males that were fighting on the scene while providing aid to [REDACTED], who was unconscious but breathing. Ptl. [REDACTED] requested Rowan Communications to dispatch EMS to the scene. Ptl. [REDACTED] arrived on the scene while Ptl. [REDACTED] was assessing [REDACTED]. While Ptl. [REDACTED] was evaluating [REDACTED] She stood up, ran towards the group of individuals, and struck student [REDACTED]. At that time, [REDACTED] was detained, and [REDACTED] was detained for not complying with verbal commands, his aggressive demeanor, and for his safety due to his level of intoxication. EMS arrived on the scene and evaluated [REDACTED] but she denied medical attention. At that time, EMS evaluated [REDACTED] due to him beginning to lose consciousness and vomiting. [REDACTED] was transported to Inspira Hospital in Mullica Hill for further evaluation. Ptl. [REDACTED] spoke with student [REDACTED] and non-student [REDACTED], and [REDACTED] advised that [REDACTED] was following them. [REDACTED] and [REDACTED] tried to get [REDACTED] to stop following them and [REDACTED]. At that point, is when the altercation ensued. While Ptl. [REDACTED] was on the scene, non-student [REDACTED] advised that she witnessed the incident from her apartment at [REDACTED]. [REDACTED] advised that she did not see anyone strike [REDACTED] but she was pushed out of the altercation as it was occurring, and that is when she hit her head. After speaking with [REDACTED] Ptl. [REDACTED] inquired if [REDACTED], or [REDACTED] wished to pursue charges for the incident, but they declined to pursue charges. At that time, Ptl. [REDACTED] responded to Inspira Hospital but could not speak with [REDACTED] due to his level of intoxication. Before leaving, Ptl. [REDACTED] left a card with contact information, so [REDACTED] could provide a statement when

he could do so. At that point, Ptl. [REDACTED] was clear from the incident.

On January 2, 2023, I began to review camera footage from the incident. There is video footage from Rowan University's Surveillance System (Genetec) and Nexus Properties Surveillance System. While reviewing the Nexus Properties Surveillance System, Sgt. [REDACTED] (#28418) advised that he had just received a phone call from [REDACTED] ([REDACTED]) requesting an update on the investigation (recorded on BWC). After speaking with [REDACTED] DSgt. [REDACTED] and I responded to Inspira Hospital to speak with [REDACTED] and [REDACTED]

DSgt. [REDACTED] and I arrived at Inspira Hospital at approximately 1:30 PM on January 2, 2023. We located [REDACTED] ([REDACTED]) and [REDACTED] in the ICU hallway, in front of room 306; I activated my BWC. While speaking to [REDACTED] and [REDACTED], I introduced myself and provided [REDACTED] with my business card. [REDACTED] advised that [REDACTED] was currently in with the nursing staff and we could see him shortly. [REDACTED] explained that [REDACTED] could not remember anything from the incident. I explained that before responding to the hospital, I was watching the surveillance footage of the incident. [REDACTED] then questioned if what she was told matched up to what I observed while what the surveillance footage. I explained that some of it did, but some of it did not. I inquired about how she saw the video footage, and she explained that she did not see the video footage, but [REDACTED] received a text from an unknown person that [REDACTED] would not provide. [REDACTED] began to inquire about what else was observed in the surveillance footage, but I explained that I could not release any information due to the ongoing investigation. Shortly after, the nursing staff advised [REDACTED] and [REDACTED] that it was ok for them to return to the room and that [REDACTED] advised that it was ok for DSgt. [REDACTED] and myself to speak with him. Upon entering the room, I advised [REDACTED] that I was Investigator [REDACTED] from Rowan Police and inquired about how he was feeling. [REDACTED] said he was ok but could not remember what occurred upon asking. In addition, [REDACTED] could not remember if he was at a party or if he was drinking alcohol at a party. At that point, [REDACTED] was asked if he was drinking, and he answered yes. [REDACTED] could not remember if he left a party with anyone and [REDACTED] advised that the doctor informed them that it could be a couple of days before he got his memory back, but he could also not get his memory back. [REDACTED] advised that [REDACTED] had the following injuries:

Stitches on his right hand

Left cheekbone could be fractured (waiting for a follow-up visit to Ear, Nose, and Throat Specialist)

Marks around his neck

At that point, ██████ requested to watch the video, and he was advised that there was more to the story than what he was being told. DSgt. ██████ asked if ██████ had ingested any illegal substances, and ██████ answered yes. He further elaborated that he was drinking from a "handle" of Jack Daniels and beer. DSgt. ██████ further inquired what ██████ meant by a "handle." ██████ explained that it was vodka but then later explained that it was a smaller bottle of alcohol and not a larger bottle. When questioned, ██████ admitted that he remembered having a bottle of brown liquor. DSgt. ██████ explained that it seemed like they were only told a portion of the incident but were not told the entire incident. It was further described that we still must review more footage from different cameras. DSgt. ██████ begins to summarize the incident, and while doing so, ██████ asks if we could tell him who we have identified so far in the investigation.

██████ advised that he thinks we was with one of the male's girlfriends, but he doesn't remember, and then that male did what he did. ██████ says the male's name is ██████ and ██████ says ██████ last name is ██████. ██████, ██████, and ██████ all say that ██████ is not friends with ██████. DSgt. ██████ and I continued to explain what we saw on the surveillance video, and multiple times, DSgt. ██████ had to stop and explain that there is a lot of tension in the room, and we understand that they are extremely frustrated with the incident, but we are relaying what we observed on the surveillance footage from what we currently viewed. ██████ advised that the individuals involved in the incident all know ██████ friends, and if they were truly his friends, they would have called 9-1-1 or ██████ friends. While explaining what occurred in the elevator, an unknown male wearing a black shirt inserts himself into the altercation. It is undetermined who the male is, and it does not appear that he knows anyone in the group, but ██████ explains that the male in the black shirt is friends with ██████. Before DSgt. ██████ and I arrived at the hospital, ██████ advised that she went to Glassboro Police Department to see why the investigation was taking so long. DSgt. ██████ advised as soon as the Rowan patrol Sergeant notified him that she wanted to speak with us, I contacted her via phone. Then within approximately twenty minutes, DSgt. ██████ and I were at the hospital to speak with them. ██████ was advised that there is going to be a report generated, and it will be available once the investigation is completed. At that point, DSgt. ██████ continues summarizing the surveillance video. After summarizing the video, I provided ██████ with the case number for the incident. While doing so, ██████ mentioned that ██████ fled to Philadelphia and is involved in a frat. ██████ noted that ██████ is always in trouble and is in and out of jail and the reason he fled was not to be questioned about the incident.

██████ was unable to identify the ██████, but did identify ██████. It was explained that ██████ appeared to be trying to help ██████ and were friendly. It was mentioned that ██████ was petting ██████ face, and he was playing with ██████ beard. It explained that at one point, ██████ was on ██████ back with his arm around ██████ neck and ██████ mentioned that's when I

passed out. [REDACTED] questioned if he remembered what happened, but [REDACTED] answered no, I don't remember anything at all, but that's when I'm guessing I went out. [REDACTED] further explained that his friends saw him on video, and that is when he went unconscious for two minutes. DSgt. [REDACTED] explained that the objective of visiting them at the hospital is not to be confrontational. It is to gather the facts, be transparent and help [REDACTED]. He further explained that the primary goal of the investigation after we leave is to identify the male in the black shirt. [REDACTED] questioned if we saw the gold chain [REDACTED] was wearing, and during the video, he was wearing the chain. [REDACTED] explained that the gold chain was missing, and they walked the "boulevard" looking for the chain. DSgt. [REDACTED] extended the offer to have them return to our headquarters, and we can show them the video as a courtesy. In addition, we hope that when [REDACTED] sees the video, he can begin to remember the events.

Before leaving, I photographed [REDACTED] injuries, and while doing so, the camera battery died. I continued to document [REDACTED] injuries on my BWC. I requested that [REDACTED] email me the pictures that she took while [REDACTED] was unconscious in the hospital (recorded on BWC).

Upon returning to the station, the photographs were logged into the Beast Evidence System.

Upon reviewing the surveillance cameras, I observed the following on January 1, 2023.

Genetec Surveillance Cameras:

3:01:21 AM: Three males are observed walking from [REDACTED] Glassboro, NJ, towards [REDACTED] and crossing [REDACTED] at 3:01:49 AM and are seen at the corner of [REDACTED] and [REDACTED] at 3:02:01 AM. They are described as follows:

[REDACTED] – white male wearing a white long-sleeve shirt, blue jeans, and an orange hat

[REDACTED] – white male wearing a light blue shirt and dark blue jeans

[REDACTED] – black male wearing a white shirt and khaki-colored pants

While the three males are walking together towards Rowan Boulevard, Edwards is seen dancing around a stop sign at Main Street and Victoria Street and jumping off an electrical box. The three males continue towards 230 Victoria Street after crossing Rowan Boulevard.

Nexus Properties Surveillance Cameras:

3:04:27 AM: [REDACTED] is observed walking into the [REDACTED] Elevator Lobby on the 6th floor and enters the elevator at 3:04:34 AM. [REDACTED] is wearing gray hooded sweater and pajama pants. [REDACTED] takes the elevator to the 1st floor and exits the elevator at 3:05:16 AM. While [REDACTED] is in the elevator, [REDACTED] and [REDACTED] arrive at [REDACTED] and enter the vestibule at 3:04:51 AM. As they enter, [REDACTED] has a "handle" of Tito's Vodka (1.75 liters), and [REDACTED] has a clear bottle of what appears to be a brown liquid. While waiting in the vestibule, [REDACTED] is observed

pulling on the locked door to [REDACTED] multiple times while [REDACTED] is using his phone and [REDACTED] is talking to [REDACTED]. As [REDACTED] walks towards the door, [REDACTED] heads to the door and puts his left arm around [REDACTED]. At 3:05:29 AM, [REDACTED] opened the locked door to allow the males into the building. [REDACTED] holds the door for [REDACTED] and [REDACTED] and follows them into the main lobby of [REDACTED].

3:05:36 AM: [REDACTED], and [REDACTED] are all seen in the lobby of [REDACTED]. As the group is walking towards the elevator, [REDACTED] appears to lose her balance as her right slipper comes off her foot and falls into [REDACTED].

3:06:06 AM: The four of them enter the elevator. Upon entering the elevator, [REDACTED] looks directly into the camera, begins talking to the camera, and then points at the camera while Douma, [REDACTED] and [REDACTED] follow behind [REDACTED]. Finally [REDACTED] turns towards the rest of the group and continues conversing with them.

When [REDACTED] enters the elevator, his bottle of Tito's appears to be one-quarter filled, and [REDACTED] bottle is approximately one-third filled. At 3:06:38 AM, [REDACTED] moves closely toward [REDACTED] to speak with her. At one point, he appears to place his hands on her shoulders while talking to [REDACTED]. At 3:06:45 AM, [REDACTED] begins drinking from his bottle but stops before the liquid exits. At 3:06:52 AM, [REDACTED] and [REDACTED] place their arms around each other and continue to talk to the rest of the group. Finally, at 3:06:58 AM, the elevator reaches the 6th floor of [REDACTED].

3:07:02 AM: [REDACTED], and [REDACTED] all exit the elevator while [REDACTED] remains in the elevator, but [REDACTED] returns to the elevator to give [REDACTED] a hug, followed by [REDACTED]. While [REDACTED] is hugging [REDACTED], he is talking into [REDACTED] ear, but I cannot hear what is being said due to the surveillance cameras not being equipped with audio. After [REDACTED] and [REDACTED] finish hugging, they shake hands while standing on the elevator's threshold. At that point, [REDACTED] steps back towards the rear wall of the elevator but then goes back towards [REDACTED] and hugs him at 3:07:34 AM. At 3:07:41 AM, [REDACTED] and [REDACTED] shake hands, and the elevator doors begin to shut at 3:07:44 AM, and [REDACTED] stops the elevator door from shutting at 3:07:46 AM. The elevator door begins to shut again at 3:07:52 AM, but it is stopped by [REDACTED], who is still talking to [REDACTED]. The elevator door shuts again at 3:07:55 AM but is stopped by [REDACTED], and then occurs a fourth time at 3:08:00 AM as [REDACTED] and [REDACTED] are shaking hands. At 3:08:06 AM, [REDACTED] leans into the elevator to continue the conversation with [REDACTED]. While [REDACTED] and [REDACTED] are talking, the elevator door attempts to close and is stopped by [REDACTED]. At 3:08:16 AM, [REDACTED] begins to exit the elevator, and [REDACTED] begins to walk towards the elevator doors and exits the elevator at 03:08:20 AM. As [REDACTED] and [REDACTED] exit the elevator, [REDACTED] leaves the elevator lobby and exits the lobby camera view, and [REDACTED] joins the conversation with [REDACTED] and [REDACTED]. At 3:08:22 AM, the elevator door starts to close, and [REDACTED] stops the door with his right hand, and [REDACTED] stops it with his right foot. [REDACTED] then re-enters the elevator and talks with [REDACTED] and [REDACTED]. At 3:08:30 AM, [REDACTED] returns to the elevator lobby. The four continue to talk as [REDACTED] steps back into the elevator. At 3:09:04 AM, [REDACTED] takes a step back from the elevator, sits on the floor, and pushes himself back with his arms raised to the height of his chest, and [REDACTED] helps [REDACTED] up at 3:09:08 AM. [REDACTED] and [REDACTED] return to the elevator as the door

is shutting and is then stopped by [REDACTED]. They continue talking on the elevator/lobby threshold and lobby. At 3:09:49 AM, [REDACTED] steps out of the elevator and prevents the door from shutting. The group is still talking as [REDACTED] is standing near the elevator door, preventing it from shutting. At 3:10:21 am, [REDACTED] steps into the lobby and drops the clear bottle with a brown liquid on the floor as the elevator door shuts, but is able to stop the door from shutting all the way. While [REDACTED] stops the door from shutting, [REDACTED] picks up the clear bottle with a brown liquid and hands it back to [REDACTED]. At 3:10:27 AM, [REDACTED] puts [REDACTED] into the elevator, and [REDACTED] hugs [REDACTED]. At 3:10:36 AM, [REDACTED] holds the clear bottle with a brown liquid with his right hand and extends it towards [REDACTED] as [REDACTED] removes the top from the bottle. The top of the bottle is removed at 3:10:42 AM, and while [REDACTED] goes to drink from the bottle, he is making a swirling motion with the bottle as he is drinking the brown liquid. Before [REDACTED] drank from the bottle, it was approximately one-third filled. [REDACTED] began to drink from the bottle at 3:10:41 AM and finished the bottle at 3:10:53 AM. After [REDACTED] finished the bottle, he handed the empty bottle to [REDACTED], and [REDACTED], [REDACTED], and [REDACTED] entered the elevator with [REDACTED]. [REDACTED] is standing towards the back of the elevator with [REDACTED] in close proximity to [REDACTED]'s face. [REDACTED] is pointing towards his left eye with his left hand. During this interaction, [REDACTED] and [REDACTED] shake hands. They stop shaking hands at 3:11:10 AM, and [REDACTED] touches [REDACTED] face with an open hand approximately four times. At this point, [REDACTED] appears to become upset with [REDACTED] action. [REDACTED] steps closer to [REDACTED], and she appears agitated with [REDACTED] actions. In addition, [REDACTED] appears to be agitated and is leaning toward [REDACTED] with his hands by his side. [REDACTED] appears to be speaking to [REDACTED] sternly with her right hand extended towards [REDACTED]'s chest. At 3:11:26 AM, [REDACTED] begins to step back from [REDACTED] as [REDACTED] is still speaking with [REDACTED]. At 3:11:43 AM, it appears that [REDACTED] and [REDACTED] interlock their little fingers as if they were making a "pinky promise" and continue holding hands until [REDACTED] hugs [REDACTED] at 3:12:05 AM. During that encounter, [REDACTED] and [REDACTED] are near the elevator's entrance. [REDACTED] is on the ground laughing near the elevator control panel, and [REDACTED] is standing on the threshold of the elevator and the lobby of the 6th floor. At 3:12:15 AM, [REDACTED] hands [REDACTED] a phone with the number keypad visible. [REDACTED] begins to enter a phone number into the phone but then deletes the number he entered into the phone. As [REDACTED] finishes deleting the number from the phone, [REDACTED] says something to [REDACTED], which causes her to spin around and put her hand up toward [REDACTED]. As [REDACTED] is doing that, [REDACTED] walks towards [REDACTED], who is standing in the corner near the elevator control panel. [REDACTED] appears to be laughing and slapping his hand on the elevator wall. [REDACTED] wraps his hands around [REDACTED] waist, and shortly after [REDACTED] moves to the center of the elevator and then back to the elevator control panel while still laughing. [REDACTED] is speaking with [REDACTED] and he goes to hug her at 3:13:09 AM and then drops the phone. [REDACTED] picks up the phone and hands the phone back to [REDACTED]. At 3:13:28 AM, [REDACTED] appears extremely excited and uses his hand while speaking to [REDACTED]. [REDACTED] appears to push [REDACTED] away, and [REDACTED] jumps up and down. At the same time, [REDACTED] is picking [REDACTED] back up, and [REDACTED] leaves the elevator and goes to the main entrance, where the two unknown males and one unknown female are located. At 3:21:11 AM, [REDACTED] is observed talking to the two unknown males and one the unknown female. [REDACTED] is observed pointing towards the elevator while speaking to the male in the white and blue jacket.

In the elevator at 3:21:07 AM, [REDACTED] speaks to [REDACTED]. However, their faces appear to be a foot apart. [REDACTED] then proceeds to hug [REDACTED], and [REDACTED] becomes increasingly agitated. At 3:21:20 AM, [REDACTED] pushes [REDACTED] towards the exit of the elevator. [REDACTED] and [REDACTED] is trying to get [REDACTED] off of him. [REDACTED] was able to separate [REDACTED] and [REDACTED]. At 3:19:17 AM, [REDACTED] backs out of the elevator, and [REDACTED] tries to get [REDACTED] out of the elevator, but [REDACTED] tries to exit the elevator. As [REDACTED] tries to exit the elevator, [REDACTED] grabs [REDACTED] right arm and shirt and pulls [REDACTED] back into the elevator.

At 3:14:48 AM, [REDACTED] and [REDACTED] are in the 6th-floor lobby of [REDACTED]. [REDACTED] has both of his hands around [REDACTED] waist, and they are facing each other. [REDACTED] holds the bottle of Tito's in the air, and [REDACTED] points to the level of fluid still left in the bottle. [REDACTED] goes to touch his head and knocks his hat off his head. [REDACTED] picks up the hat and tries to assist [REDACTED] with putting the hat back on his head, but [REDACTED] and [REDACTED] start hugging each other. While they are hugging, [REDACTED] begins to pull [REDACTED] away from [REDACTED] and [REDACTED] then brings [REDACTED] to the elevator and pushes the button for the elevator. [REDACTED] and myself (recorded on BWC). While watching the footage, I was able to confirm what [REDACTED], and [REDACTED] were wearing during the incident. While watching the footage, I asked if [REDACTED] remembered where he was coming from, and [REDACTED] replied, "six," and I further clarified, "[REDACTED]" [REDACTED] then confirmed he came from [REDACTED] explained that from what she heard, [REDACTED] and [REDACTED] convinced [REDACTED] to come back to [REDACTED] and that he was set up due to [REDACTED] level of intoxication. In addition, [REDACTED] advised that once they see a specialist, the Doctor will be able to determine that the fracture to [REDACTED] face was from blunt force and not a fall. DSgt. [REDACTED] advised that there could be some time difference from Nexus's camera system. [REDACTED] commented that everyone involved in the incident was his friend. While watching [REDACTED] opens the doors for [REDACTED] and [REDACTED] advised that she set him up, and [REDACTED] told him to relax, especially since he had just gotten out of the hospital. [REDACTED] mentioned that [REDACTED] did not appear to be stumbling as she entered the elevator. [REDACTED] recognized [REDACTED] but did not know his name. [REDACTED] advised that it looks like [REDACTED], and [REDACTED] are "pressing" him in the elevator. [REDACTED] was then asked if the bottle he was holding was the whiskey he mentioned when we were at the hospital. DSgt. [REDACTED] then points to the video, and [REDACTED] is holding a bottle in his left hand. Upon asking if he remembered anything from the incident, [REDACTED] replied no but understood why we might think they were boys. [REDACTED] continued to explain he didn't know why he was there. [REDACTED] explained that everyone that visited [REDACTED] could not understand why [REDACTED] left with them since they weren't friends. Douma explained that, looking at his body language, he did not want to be there. [REDACTED] mentions that his necklace is missing while he is in the elevator, but it was pointed out that he was wearing the necklace in the elevator. [REDACTED] questions why [REDACTED] appears to be giving [REDACTED] his phone number when [REDACTED] is holding the phone. [REDACTED] mentions that [REDACTED] is "laughing his ass off" and that he was putting a number into a phone and explains that [REDACTED] ego was hurt. While reviewing the footage, [REDACTED] kept asking where he was assaulted and where he fell and was told to let the video play. DSgt. [REDACTED] points out to [REDACTED] that his shoes come off when he falls. [REDACTED] mentions that he ([REDACTED]) has his hand around [REDACTED] while in the elevator. [REDACTED] explained that we did not want to get into an argument based on opinions. We showed her the video to show that we were transparent with the investigation. As the elevator doors open on the 1st floor, DSgt. [REDACTED] asked to pause the video to show [REDACTED] and [REDACTED] the unknown male in the black shirt, who later assaulted [REDACTED]. [REDACTED] could not identify the male in the black shirt, but [REDACTED] questioned if that was the guy from back home. [REDACTED] is sure he is friends with [REDACTED] and could get his name. [REDACTED] mentions from her perspective that it appears that the other two kids were instigating it before the male in the black shirt entered the elevator. [REDACTED] mentions when [REDACTED] kicks [REDACTED] in the elevator. [REDACTED] points out that [REDACTED] rips his chains off his neck while still in the elevator. [REDACTED] mentions that everything they heard from [REDACTED] friend about the video was 100% correct. [REDACTED] tells [REDACTED] that they are going full fledge and are not getting away with it. She continues to say that she doesn't care what [REDACTED] did up to that point, and everything is black and white. [REDACTED] mentions that they instigated him the whole time and continues to say that [REDACTED] was obliterated the whole time. [REDACTED] mentioned that he did not know who the male in the black shirt was and further elaborated that this was the first time he was in [REDACTED] this year. [REDACTED] mentioned that [REDACTED] wasn't moving when he was on the ground, and [REDACTED] was on top of him. After watching the surveillance footage, DSgt. [REDACTED] advised [REDACTED] that we knew who everyone was except for the male in the black shirt. DSgt. [REDACTED] requested [REDACTED] to return later to provide a victim statement since he was just released from the hospital. [REDACTED] explained that \$3000.00 dollars of jewelry were taken from him during the incident. DSgt. [REDACTED] advised that they may have, when [REDACTED] returns, to make his statement bring receipts for the necklace and any other paperwork. Upon [REDACTED] asking if they could have the video from the incident, she was advised that it is still an ongoing investigation and showing her and [REDACTED] the video was a courtesy and normally we would not be doing this. At that time, the viewing of the surveillance footage was over, and [REDACTED] and [REDACTED] left Rowan University Police.

I also received an email from [REDACTED] with a photograph of [REDACTED] in the hospital bed.

with me around 2:00 PM on January 5, 2023 (recorded on BWC).

On January 5, 2023, at approximately 10:28 AM, I contacted the witness, non-student [REDACTED] via phone. [REDACTED] advised that she was at the Doctor's office but could speak with me over the phone. I asked [REDACTED] to explain to me what she saw during the incident, and it is summarized as follows:

[REDACTED] explained that she was still up due to it being New Year's and the college kids are typically loud, but that night the college kids were extra loud, and she went to look out the window. [REDACTED] explained that she lives at [REDACTED] and her window faces [REDACTED]. [REDACTED] explained that she saw the black male sitting on the curb, the kid with the fluffy hair was with the female, and the male in the white shirt was messing with the others. [REDACTED] explained that the female was going between the two white males, and the black male was sitting on the curb most of the time. The group told the white shirt male to go away and that they did not want him there. They were also telling the male in the white shirt to leave. [REDACTED] continued to watch because they kept telling the male in the white to leave, but he kept coming back to the others. [REDACTED] felt they were going to fight and continued to watch and elaborated that the male in the white shirt would not leave the front of the building. She was unsure who started the fight, but the female tried to get into the middle of the fight with the males. During the fight, the female fell and hit her head on the ground. [REDACTED] explained that the female hit her head on the ground so hard she heard it from her apartment, and that's when the police arrived. [REDACTED] described the males fighting as the black male, the male with the white shirt, and the male with the fluffy hair. She later stated that the fluffy-haired male wore a blue or gray shirt. [REDACTED] explained that she only saw the incident from when the black male was sitting on the curb to when the police showed up. At that time, the phone conversation was ended (recorded on BWC).

At approximately 2:00 PM, [REDACTED] and [REDACTED] arrived at Bole Annex. Rowan Communication was advised that I would be interviewing [REDACTED] and [REDACTED]. I asked [REDACTED] to wait in the lobby and escorted [REDACTED] into the interview room.

While in the interview room, I reintroduced myself and advised that she could leave at any time but just to let me know so I could escort her out. I then explained to [REDACTED] her Miranda Rights.

[REDACTED] was read her Miranda Rights aloud and signed and agreed to waive her Miranda Rights. [REDACTED] interview is summarized as follows:

[REDACTED] advised that she was at a party at [REDACTED] in Glassboro, NJ, with [REDACTED] and a few of her friends from home. She explained that she left the party with [REDACTED] and her friends, but halfway back to [REDACTED] forgot he had brought [REDACTED] to the party and returned to the party at [REDACTED]. Approximately an hour later, she got a call from [REDACTED] asking her to open the door to [REDACTED] and at the same time, three of her other friends said they were on their way to her apartment. [REDACTED] and [REDACTED] were at the entrance when she got to the door from her room on the 6th floor. [REDACTED] then asked if he could stay at her apartment, but she said no because she did not have any room for her friends staying there and [REDACTED] friends staying there. In addition, she noticed how intoxicated [REDACTED] was and did

not want him in her apartment, but she did not verbalize that to [REDACTED] advised that he could not walk home or it was unsafe, so [REDACTED] asked him for her number and told him that she could be on the phone with him until he got home safely. At that time, [REDACTED] was out of the elevator, and [REDACTED] would not let go of her arm. [REDACTED] then pushed [REDACTED] because he would not let go of [REDACTED] [REDACTED] explained that [REDACTED] shoes fell off. At that time, [REDACTED] and [REDACTED] tried to get [REDACTED] back into the elevator to leave the building. While in the elevator, she couldn't remember if [REDACTED] was attempting to fight [REDACTED] or [REDACTED] or if [REDACTED] or [REDACTED] were trying to fight [REDACTED] but [REDACTED] remembered holding [REDACTED] by his collar so he couldn't touch anyone.

[REDACTED] other friends called while they were in the elevator, and she told them that they were having issues with a kid and she would be right down. Once the elevator doors opened, [REDACTED] ran to her friends at the entrance of [REDACTED] and told them what was happening, and then the two guys and the girl ran towards the elevator. Upon returning to the elevator, [REDACTED] and [REDACTED] are fighting, and [REDACTED] then tries to hold [REDACTED] down to stop the fight. [REDACTED] couldn't remember if [REDACTED] pushed or hit her, but that was when her friend [REDACTED] started to punch [REDACTED] in the head. [REDACTED] explained that it was extremely chaotic at that moment and couldn't remember everything that was happening. [REDACTED] explained that the incident moved further into the lobby, and she remembered holding [REDACTED] down and then asking her friend for her phone, which was in the elevator. [REDACTED] knew [REDACTED] was in the [REDACTED] fraternity and wanted to call a few of his friends to come to get him. Her friend gave [REDACTED] the friends phone. [REDACTED] explained that [REDACTED] couldn't leave, and [REDACTED] attempted to call a member of [REDACTED] fraternity to come to get him, but none answered. From what she remembers, [REDACTED] choke him at one point, and [REDACTED] dragged him outside. [REDACTED] was trying to hold the door shut so [REDACTED] could not get back in, but then she didn't remember how they got outside. Siddiquei explained that she was holding [REDACTED] because [REDACTED] and [REDACTED] were trying to fight [REDACTED] and [REDACTED] was attempting to fight [REDACTED] and [REDACTED]. While holding [REDACTED] she wasn't sure if [REDACTED] pushed her or if when [REDACTED] punched her when she fell. [REDACTED] advised that she was not unconscious. Instead, she was overwhelmed by what had happened. When she got up, she went over and punched [REDACTED] in front of the officers on the scene.

[REDACTED] explained that she felt threatened by [REDACTED] because she told him no, that he couldn't stay over, and he would not leave. [REDACTED] advised that she never made advances towards [REDACTED]. She identified her friends as non-student [REDACTED], non-student [REDACTED], and student [REDACTED] and provided their phone numbers. [REDACTED] was then shown photographs and identified her friends in the pictures. Finally, [REDACTED] advised that she was receiving threatening messages from a member of the [REDACTED] fraternity regarding the incident, and [REDACTED] father received a threatening phone call. She advised that [REDACTED] would tell me about the phone call. At that time, the interview was concluded, and [REDACTED] was escorted out of the interview room (recorded on in station video).

After escorting [REDACTED] from the interview room, I ended the in-station video recorder and started a new recording before escorting [REDACTED] into the interview room.

Upon escorting [REDACTED] into the interview room, I advised him that he could leave at any time, just to let me know so I could escort him. I then explained to [REDACTED] his Miranda Rights. [REDACTED] was read his Miranda Rights aloud and signed and agreed to waive his Miranda Rights. [REDACTED] interview is summarized as follows:

[REDACTED] was at a party at [REDACTED] in Glassboro, NJ, with a few of his friends and met [REDACTED] at the party. They were hanging out for an hour before leaving for his girlfriend's, [REDACTED] apartment. Once they got out of the elevator, [REDACTED] asked to go to [REDACTED]'s room, but she said no. [REDACTED] explained that [REDACTED] grabbed [REDACTED] arm, and that's when [REDACTED] pushed [REDACTED] backtracked and explained that while in the elevator going to the 6th floor, [REDACTED] drank approximately a 1/2 bottle of rum on his own without anyone saying anything to him. As time went on, [REDACTED] began to become more out of it. They were trying to get him in the elevator, and he was more restless and resisting. When they arrived back on the 1st floor of the elevator, [REDACTED] exited the elevator to let [REDACTED] home town friends into the building. Once his friends came over, he advised that he saw [REDACTED] put his hand on [REDACTED]. [REDACTED] explained that he was trying to de-escalate the incident and believed that he had only punched [REDACTED] once but couldn't remember. While [REDACTED] was on the ground, [REDACTED] said he would beat them up. [REDACTED] remembers picking [REDACTED] up and bringing him outside, and they were trying to keep him outside. That is when [REDACTED] saw the police car pulling up, and the officer told everyone to get on their knees; and [REDACTED] started to give the officer a hard time, then the officer pulled [REDACTED] aside to talk to them.

Upon asking [REDACTED] how he left the party, he advised that he first left with [REDACTED], but returned to the party to get his friend [REDACTED]. While back at the party with [REDACTED], they began to party with [REDACTED]. [REDACTED] was unsure how they entered [REDACTED]. He believed that a random person opened the door for them. [REDACTED] explained how he knew non-student [REDACTED], non-student [REDACTED] and student [REDACTED]. Rights aloud and signed and agreed to waive his Miranda Rights. [REDACTED] interview is summarized as follows:

[REDACTED] advised that he was hanging out with [REDACTED] and [REDACTED] a party off campus. [REDACTED] and he left the party early and went to [REDACTED] apartment at [REDACTED]. After spending time at [REDACTED] apartment, they went to [REDACTED] to meet with [REDACTED] and [REDACTED]. While [REDACTED] i, and [REDACTED] were walking to [REDACTED], they were informed that [REDACTED] and [REDACTED] were having an issue with a kid that wouldn't leave them alone. Once they arrived at [REDACTED] they were let into the building by [REDACTED]. Once entering the building, [REDACTED] told them that a male was giving them problems, wouldn't leave them alone, and cursing at them. [REDACTED] explained that he witnessed [REDACTED] place his hands on [REDACTED] multiple times and felt that [REDACTED], [REDACTED], and [REDACTED] were endangered. [REDACTED] explained that he restrained [REDACTED] and told him to stop, that what you're doing was not "OK," and he needed to leave the building. At that point, [REDACTED] said OK, and [REDACTED] let him go, but when he got up [REDACTED] continued to try fighting everyone, placing his hands on [REDACTED] and cursing at everyone. [REDACTED] explained that he felt he needed to restrain him again, but his girlfriend, [REDACTED] would not let him. [REDACTED] explained that he was out of the situation but watching [REDACTED] and [REDACTED] continue fighting outside the building. [REDACTED] explained that he tried to go outside to help, but the police pulled up as he walked to the door.

Upon questioning how he restrained [REDACTED] explained that he placed him in an arm bar and held him in the elevator. After he let go of [REDACTED] they exited the elevator and were in the lobby. Once he left the elevator, [REDACTED] pulled him aside and stopped him from engaging in the fight. When questioning [REDACTED] about what he saw outside, he replied that he saw them yelling and screaming but did not go out.

At that point, I asked if he had any questions for me and [REDACTED] answered no. I advised him that he was now under arrest for simple assault because what he told me was not what I observed on the surveillance footage. I advised [REDACTED] that he did leave the building when he advised that he remained inside the building and that the way he restrained [REDACTED] was different from what was observed on video. I advised [REDACTED] that he body-slammed [REDACTED] on the ground and punched him seven to eight times on his ribs. If he was trying to defuse the situation, his actions on video did not show that [REDACTED] was escorted into the holding room, where he was searched, processed, and released on Summons 2023-000055 for Simple Assault (2C:12-1a(1)). In addition, [REDACTED] was issued a Trespass Warning.

On January 12, 2023, at approximately 3:55 PM, I attempted to contact [REDACTED] via phone. However, I left a voicemail requesting [REDACTED] to return the phone call (recorded on BWC).
