The reporting party (Denise Capizzi) stated that she found drug paraphernalia in her daughter's room that she wished to turn over to the police department. The property included one glass bong (clear in color) and two glass smoking pipes (multicolored). Ms. Capizzi stated that she located the property inside of her daughter's room (Cailyn Capizzi). She stated that she believed the property to be used for smoking marijuana. I collected the property and transported it to the Berkeley Township Police Department. Once at police headquarters, I completed a property voucher and stored the items in evidence locker #7. There are no charges or complaints associated with this property, Ms. Capizzi stated that she just did not want it inside of her residence. It must be noted that Ms. Capizzi was advised that her daughter is a legal adult and does have a right to privacy in her bedroom. As a result of this, Ms. Capizzi was also advised that she cannot enter her daughter's bedroom without her permission. This officer wore camera #113 during this incident.
